STATEMENT OF WORK

PURPOSE

In accordance with Section 503 of Public Law 100-71, 5 U.S.C. Section 7301, and as mandated by Executive Order 12564, Drug-Free Federal Workplace Program, the South Texas Veterans Health Care System (STVHCS) must establish a drug-free workplace through mandatory urine drug testing of all prospective employees in certain designated positions and also maintain random drug testing of current employees.

BACKGROUND

Drug testing was previously conducted on-site, and randomly for certain occupational positions. However, Veterans Administration Central Office now requires all new employees in these certain occupational positions be tested, while still maintaining random testing of current employees. The total estimated numbers of pre-employment and current employee testing is 750 per year.

OBJECTIVES

Provide timely 5-panel drug testing and release results directly to a STVHCS Medical Review Officer (MRO).

SCOPE OF WORK

Contractor shall be responsible to source the nearest nationwide collection site for the individual being tested. Drug testing collection must be available nationwide. The contractor must have samples analyzed by a current Department of Health and Human Services (HHS) Substance Abuse and Mental Health Services Administration (SAMHSA) certified laboratory. Results must be documented on the most current Federal Drug Testing Custody and Control Form (CCF) (digital or electronic version). Urine collection and analysis is for both pre-employment applicants and random sampling of current employees and must follow the most current Mandatory Guidelines for Federal Workplace Drug Testing. The vendor must satisfy all requirements in subparts D, E, F, G and H of the Mandatory Guidelines for Federal Workplace Drug Testing Programs (HHS Mandatory Guidelines) published on November 25, 2008 (effective October 1, 2017).

The collection site must have a means for the donor to wash his or her hands prior to and after urination. The work area is used by the collector to handle the specimens and to complete required paperwork (e.g., Federal CCF). The collector work area should be external to the restroom where the collection occurs; however, it may be inside the restroom, if the donor still has privacy while providing the urine specimen. The work area must be clean and not accessible to the donor. The collection site must have an appropriate secure temporary storage area for maintaining specimens. The specimen storage area should not be exposed to elevated temperatures for an extended period, as this may affect the test results of a urine specimen.

The collection site must have the name and telephone number of the designated representative for each Federal agency readily available, so collectors can contact the agency as needed about problems or issues that arise during the specimen collection procedure.

Each collector is required to maintain documentation of current training and refresher training and present it to the agency upon request. The collection site may maintain the originals or maintain copies of the training documents. If the collection site provides copies for review, the inspectors may request one or more collectors to provide the originals during the inspection.

The collection site must have all the supplies needed to complete a specimen collection (e.g., collection kits, single-use collection containers and specimen bottles, Federal CCF's, tamper-evident tape/seals, leak-resistant plastic bags, absorbent material, shipping containers, bluing agent, disposable gloves). Collection kits must include a single-use collection container able to hold at least 55 mL, one specimen bottle able to hold at least 35 mL, and one specimen bottle able to hold at least 20 mL. Collection containers and specimen bottles must not substantially affect the specimen collected.

Collectors must prepare the collection site prior to specimen collection to deter dilution or substitution of the specimen. The collector must ensure that there is bluing agent in the toilet or toilet tank so that water always remains blue. If bluing agent is not available or the toilet has an automated flushing system, the collector must turn off the water supply and flush the toilet to remove any water in the toilet. The

collector must also turn off or secure other water supply inside the restroom where the collection is taking place. If the water supply cannot be secured or turned off, the collector must perform a monitored collection.

If the donor is required to arrive within a window of time and is outside of that window specified by the agency, the collector must contact the Federal agency representative to obtain guidance on the appropriate action to be taken when a donor fails to arrive at the collection site on time.

The collector must verify the identity of the donor by requesting photo identification (i.e., driver's license, employee badge issued by the employer, or other photo identification issued by Federal, state, or local government) from the donor prior to specimen collection. If the donor does not have proper photo identification, the collector must contact the supervisor of the donor or the agency representative who can positively identify the donor. If the identity of the donor cannot be established, the collector must stop the collection procedure.

The collector must ensure that Step 1 of the Federal CCF is completed prior to specimen collection. The employer, Medical Review Officer (MRO), collection site, and collector information may be preprinted or handwritten. The collector records the information if it is not present. The collector enters the donor identification information after verifying donor identity and enters a REMARK in Step 2 if the donor refuses to provide his or her social security number (SSN) or employee identification number. The collector marks the appropriate checkboxes to indicate the testing authority under which the specimen is being collected and the reason for testing. The collector also indicates the drug tests to be performed. If the drugs tests to be performed differ from those preprinted on the Federal CCF, the Federal agency must provide a memorandum for the record (MFR), and the collector must attach the MFR to the back of the Federal CCF prior to shipment to the test facility.

The collector must note any unusual appearance or behavior of the donor on the Federal CCF. If the collector detects conduct that indicates an attempt to tamper with the specimen, the collector must use the direct observed collection procedure. The collector must indicate on the CCF that a direct observed collection was performed.

Both the collector and the donor must maintain visual contact with the specimen from the time the specimen is transferred from the donor to the collector until the specimen bottles have been sealed for the testing facility.

Submission of drug testing request for pre-employment applicants will be initiated through a STVHCS Human Resources Assistant (HRA) utilizing the contractors' own on-line system on its website. All HRAs will have access to this system to request drug tests only. They will not have access to test results or even notification of test results. Once submitted, the system must display a confirmation number that the HRA will provide to the applicant. The applicant will, in turn, provide this number to the laboratory, along with a form of ID, to start and record the drug test. All actions must be done in accordance with the below mentioned documents.

DELIVERABLES

The turnaround time for reporting negative urine drug screen results, when no additional testing is required, is less than 24 hours. This measurement includes the time period from when the specimen is first received in the laboratory until the result is released by the certifying scientist and is available for reporting. Positive results that are released to a certified Medical Review Officer average an additional 24-72 hours. Results posted to the laboratory's web-based reporting tool, an internet based application that streamlines information delivery in a secure, confidential, online system. Results will be made available and accessed by South Texas Veterans Health Care System MRO and their alternate only.

PERIOD OF PERFORMANCE

Base year will start in 2018 with three option years.

INFORMATION SYSTEM OFFICER, INFORMATION PROTECTION

The contractor will not have access to VA Desktop computers and will not have access to online resources belonging to the government.

PRIVACY OFFICER

The Contractor will not have access to protected Patient Health Information (PHI), but will have the capability of accessing employee information as part of data collection during the drug testing process. If removal of equipment from the VA is required, any memory storage device will remain in VA control and will not be removed from VA custody. All research data available for Contractor analysis will be de-identified. The C&A requirements do not apply and a Security Accreditation Package is not required.

RECORDS MANAGER

Contractor shall treat all deliverables under the contract as the property of the U.S. Government for which the Government Agency shall have unlimited rights to use, dispose of, or disclose such data contained therein as it determines to be in the public interest.

Contractor shall not create or maintain any records that are not specifically tied to or authorized by the contract using Government IT equipment and/or Government records.

Contractor shall not retain, use, sell, or disseminate copies of any deliverable that contains information covered by the Privacy Act of 1974 or that which is generally protected by the Freedom of Information Act.

Contractor shall not create or maintain any records containing any Government Agency records that are not specifically tied to or authorized by the contract.

The Government Agency owns the rights to all data/records produced as part of this contract.

The Government Agency owns the rights to all electronic information (electronic data, electronic information systems, electronic databases, etc.) and all supporting documentation created as part of this contract. Contractor must deliver sufficient technical documentation with all data deliverables to permit the agency to use the data.

Contractor agrees to comply with Federal and Agency records management policies, including those policies associated with the safeguarding of records covered by the Privacy Act of 1974. These policies include the preservation of all records created or received regardless of format [paper, electronic, etc.] or mode of transmission [e-mail, fax, etc.] or state of completion [draft, final, etc.].

No disposition of documents will be allowed without the prior written consent of the Contracting Officer. The Agency and its contractors are responsible for preventing the alienation or unauthorized destruction of records, including all forms of mutilation. Willful and unlawful destruction, damage or alienation of Federal records is subject to the fines and penalties imposed by 18 U.S.C. 2701. Records may not be removed from the legal custody of the Agency or destroyed without regard to the provisions of the agency records schedules.

Contractor is required to obtain the Contracting Officer's approval prior to engaging in any contractual relationship (sub-contractor) in support of this contract requiring the disclosure of information, documentary material and/or records generated under, or relating to, this contract. The Contractor (and any sub-contractor) is required to abide by Government and Agency guidance for protecting sensitive and proprietary information.

VA CUSTODIAL LANGUAGE

- a. Information made available to the contractor or subcontractor by VA for the performance or administration of this contract or information developed by the contractor/subcontractor in performance or administration of the contract shall be used only for those purposes and shall not be used in any other way without the prior written agreement of the VA. This clause expressly limits the contractor/subcontractor's rights to use data as described in Rights in Data - General, FAR 52.227-14(d) (1).
- b. VA information should not be co-mingled, if possible, with any other data on the contractors/subcontractor's information systems or media storage systems in order to ensure VA requirements related to data protection and media sanitization can be met. If co-mingling must be allowed to meet the requirements of the business need, the contractor must ensure that VA's information is returned to the VA or destroyed in accordance with VA's sanitization requirements. VA reserves the right to conduct on-site inspections of contractor and subcontractor IT resources to ensure data security controls, separation of data and job duties, and destruction/media sanitization procedures are in compliance with VA directive requirements.
- c. Prior to termination or completion of this contract, contractor/subcontractor must not destroy information received from VA, or gathered/created by the contractor in the course of performing this contract without prior written approval by the VA. Any data destruction done on behalf of VA by a contractor/subcontractor must be done in accordance with National Archives and Records Administration (NARA) requirements as outlined in VA Directive 6300, Records and Information Management and its Handbook 6300.1 Records Management Procedures, applicable VA Records Control Schedules, and VA Handbook 6500.1, Electronic Media Sanitization. Self-certification by the contractor that the data destruction requirements above have been met must be sent to the VA Contracting Officer within 30 days of termination of the contract.
- d. The contractor/subcontractor must receive, gather, store, back up, maintain, use, disclose and dispose of VA information only in compliance with the terms of the contract and applicable Federal and VA information confidentiality and security laws, regulations and policies. If Federal or VA information confidentiality and security laws, regulations and policies become applicable to the VA information or information systems after execution of the contract, or if NIST issues or updates applicable FIPS or Special Publications (SP) after execution of this contract, the parties agree to negotiate in good faith to implement the information confidentiality and security laws, regulations and policies in this contract.
- e. The contractor/subcontractor shall not make copies of VA information except as authorized and necessary to perform the terms of the agreement or to preserve electronic information stored on contractor/subcontractor electronic storage media for restoration in case any electronic equipment or data used by the contractor/subcontractor needs to be restored to an operating state. If copies are made for restoration purposes, after the restoration is complete, the copies must be appropriately destroyed.
- f. If VA determines that the contractor has violated any of the information confidentiality, privacy, and security provisions of the contract, it shall be sufficient grounds for VA to withhold payment to the contractor or third party or terminate the contract for default or terminate for cause under Federal Acquisition Regulation (FAR) part 12.

- g. If a VHA contract is terminated for cause, the associated BAA must also be terminated and appropriate actions taken in accordance with VHA Handbook 1600.01, Business Associate Agreements. Absent an agreement to use or disclose protected health information, there is no business associate relationship.
- h. The contractor/subcontractor must store, transport, or transmit VA sensitive information in an encrypted form, using VA-approved encryption tools that are, at a minimum, FIPS 140-2 validated.
- i. The contractor/subcontractor's firewall and Web services security controls, if applicable, shall meet or exceed VA's minimum requirements. VA Configuration Guidelines are available upon request.
- j. Except for uses and disclosures of VA information authorized by this contract for performance of the contract, the contractor/subcontractor may use and disclose VA information only in two other situations: (i) in response to a qualifying order of a court of competent jurisdiction, or (ii) with VA's prior written approval. The contractor/subcontractor must refer all requests for, demands for production of, or inquiries about, VA information and information systems to the VA contracting officer for response.
- k. Notwithstanding the provision above, the contractor/subcontractor shall not release VA records protected by Title 38 U.S.C. 5705, confidentiality of medical quality assurance records and/or Title 38 U.S.C. 7332, confidentiality of certain health records pertaining to drug addiction, sickle cell anemia, alcoholism or alcohol abuse, or infection with human immunodeficiency virus. If the contractor/subcontractor is in receipt of a court order or other requests for the above mentioned information, that contractor/subcontractor shall immediately refer such court orders or other requests to the VA contracting officer for response.
- l. For service that involves the storage, generating, transmitting, or exchanging of VA sensitive information but does not require C&A or an MOU-ISA for system interconnection, the contractor/subcontractor must complete a Contractor Security Control Assessment (CSCA) on a yearly basis and provide it to the COTR.

SECURITY INCIDENT INVESTIGATION

- a. The term "security incident" means an event that has, or could have, resulted in unauthorized access to, loss or damage to VA assets, or sensitive information, or an action that breaches VA security procedures. The contractor/subcontractor shall immediately notify the COTR and simultaneously, the designated ISO and Privacy Officer for the contract of any known or suspected security/privacy incidents, or any unauthorized disclosure of sensitive information, including that contained in system(s) to which the contractor/subcontractor has access.
- b. To the extent known by the contractor/subcontractor, the contractor/subcontractor's notice to VA shall identify the information involved, the circumstances surrounding the incident (including to whom, how, when, and where the VA information or assets were placed at risk or compromised), and any other information that the contractor/subcontractor considers relevant.
- c. With respect to unsecured protected health information, the business associate is deemed to have discovered a data breach when the business associate knew or should have known of a breach of such information. Upon discovery, the business associate must notify the covered entity of the breach. Notifications need to be made in accordance with the executed business associate agreement.
- d. In instances of theft or break-in or other criminal activity, the contractor/subcontractor must concurrently report the incident to the appropriate law enforcement entity (or entities) of jurisdiction, including the VA OIG and Security and Law Enforcement. The contractor, its employees, and its subcontractors and their employees shall cooperate with VA and any law enforcement authority responsible for the investigation and prosecution of any possible criminal law violation(s) associated with any incident. The contractor/subcontractor shall cooperate with VA in any civil litigation to recover VA

information, obtain monetary or other compensation from a third party for damages arising from any incident, or obtain injunctive relief against any third party arising from, or related to, the incident.

LIQUIDATED DAMAGES FOR DATA BREACH

- a. Consistent with the requirements of 38 U.S.C. §5725, a contract may require access to sensitive personal information. If so, the contractor is liable to VA for liquidated damages in the event of a data breach or privacy incident involving any SPI the contractor/subcontractor processes or maintains under this contract.
- b. The contractor/subcontractor shall provide notice to VA of a “security incident” as set forth in the Security Incident Investigation section above. Upon such notification, VA must secure from a non-Department entity or the VA Office of Inspector General an independent risk analysis of the data breach to determine the level of risk associated with the data breach for the potential misuse of any sensitive personal information involved in the data breach. The term 'data breach' means the loss, theft, or other unauthorized access, or any access other than that incidental to the scope of employment, to data containing sensitive personal information, in electronic or printed form, that results in the potential compromise of the confidentiality or integrity of the data. Contractor shall fully cooperate with the entity performing the risk analysis. Failure to cooperate may be deemed a material breach and grounds for contract termination.
- c. Each risk analysis shall address all relevant information concerning the data breach, including the following:
 - (1) Nature of the event (loss, theft, unauthorized access);
 - (2) Description of the event, including:
 - (a) date of occurrence;
 - (b) data elements involved, including any PII, such as full name, social security number, date of birth, home address, account number, disability code;
 - (3) Number of individuals affected or potentially affected;
 - (4) Names of individuals or groups affected or potentially affected;
 - (5) Ease of logical data access to the lost, stolen or improperly accessed data in light of the degree of protection for the data, e.g., unencrypted, plain text;
 - (6) Amount of time the data has been out of VA control;
 - (7) The likelihood that the sensitive personal information will or has been compromised (made accessible to and usable by unauthorized persons);
 - (8) Known misuses of data containing sensitive personal information, if any;
 - (9) Assessment of the potential harm to the affected individuals;
 - (10) Data breach analysis as outlined in 6500.2 Handbook, Management of Security and Privacy Incidents, as appropriate; and
 - (11) Whether credit protection services may assist record subjects in avoiding or mitigating the results of identity theft based on the sensitive personal information that may have been compromised.

d. Based on the determinations of the independent risk analysis, the contractor shall be responsible for paying to the VA liquidated damages in the amount of \$37.50 per affected individual to cover the cost of providing credit protection services to affected individuals consisting of the following:

- (1) Notification;
- (2) One year of credit monitoring services consisting of automatic daily monitoring of at least 3 relevant credit bureau reports;
- (3) Data breach analysis;
- (4) Fraud resolution services, including writing dispute letters, initiating fraud alerts and credit freezes, to assist affected individuals to bring matters to resolution;
- (5) One year of identity theft insurance with \$20,000.00 coverage at \$0 deductible; and
- (6) Necessary legal expenses the subjects may incur to repair falsified or damaged credit records, histories, or financial affairs.

8. SECURITY CONTROLS COMPLIANCE TESTING

On a periodic basis, VA, including the Office of Inspector General, reserves the right to evaluate any or all of the security controls and privacy practices implemented by the contractor under the clauses contained within the contract. With 10 working-days' notice, at the request of the government, the contractor must fully cooperate and assist in a government-sponsored security controls assessment at each location wherein VA information is processed or stored, or information systems are developed, operated, maintained, or used on behalf of VA, including those initiated by the Office of Inspector General. The government may conduct a security control assessment on shorter notice (to include unannounced assessments) as determined by VA in the event of a security incident or at any other time.

TRAINING

a. All contractor employees and subcontractor employees requiring access to VA information and VA information systems shall complete the following before being granted access to VA information and its systems:

- (1) Sign and acknowledge (either manually or electronically) understanding of and responsibilities for compliance with the Contractor Rules of Behavior, Appendix E relating to access to VA information and information systems;
- (2) Successfully complete the VA Cyber Security Awareness and Rules of Behavior training and annually complete required security training;
- (3) Successfully complete the appropriate VA privacy training and annually complete required privacy training; and
- (4) Successfully complete any additional cyber security or privacy training, as required for VA personnel with equivalent information system access [to be defined by the VA program official and provided to the contracting officer for inclusion in the solicitation document – e.g., any role-based information security training required in accordance with NIST Special Publication 800-16, Information Technology Security Training Requirements.]

b. The contractor shall provide to the contracting officer and/or the COTR a copy of the training certificates and certification of signing the Contractor Rules of Behavior for each applicable employee within 1 week of the initiation of the contract and annually thereafter, as required.

c. Failure to complete the mandatory annual training and sign the Rules of Behavior annually, within the timeframe required, is grounds for suspension or termination of all physical or electronic access privileges and removal from work on the contract until such time as the training and documents are complete.

Sensitive Personal Information (SPI) – also referred to as personally identifiable information (PII) or individually identifiable information. Refers to any information about an individual maintained by an agency, including any information which can be used to distinguish or trace an individual's identity, such as their name, social security number, date and place of birth, mother's maiden name, biometric records, or any information that is linked or linkable to an individual. Education, financial transactions, medical history, and criminal or employment history are included. Individually identifiable health information, protected health information, and privacy-protected information are also included in this category. Below is additional clarification of these terms.

(1) Individually identifiable information – Individually-identifiable information is any information, including health information maintained by VHA, pertaining to an individual that also identifies the individual and, except for individually-identifiable health information, is retrieved by the individual's name or other unique identifier. Individually-identifiable health information is covered regardless of whether or not the information is retrieved by name.

(2) Individually identifiable health information - Individually-identifiable health information is a subset of health information, including demographic information collected from an individual, that is (1) Created or received by a health care provider, health plan, employer, or health care clearinghouse; and (2) Relates to the past, present, or future physical or mental condition of an individual; the provision of health care to the individual; or the past, present or future payment for the provision of health care; and (3) Identifies the individual or a reasonable basis exists to believe the information can be used to identify the individual. Also included in this category is individually-identifiable medical or health information maintained by VA on individuals who have applied for, been or have been treated for drug and alcohol abuse, infection with sickle cell anemia or testing and treatment for infection with HIV (38 U.S.C. § 7332). Individually identifiable health information encompasses protected health information.

(3) Protected health information (PHI) – Health information maintained in any form protected under the HIPAA Privacy and Security Rules, 45 Code of Federal Regulations, Parts 160 and 164. Also included in this category is health information in a limited data set.

(4) Privacy-protected information – All individually-identifiable personal information that is protected under Federal law. Privacy-protected information encompasses personally identifiable information, individually identifiable information, individually identifiable health information, and protected health information.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.
