B.2 STATEMENT OF WORK

1.0 PROJECT DESCRIPTION

The Sioux Falls VA Health Care System (SFVAHCS) requires a **Pharmacy and Police Surveillance Camera System** to include items identified in this Statement of Work, Specifications, and requirements. Contractor must provide a turn-key solution including the electrical installation, programming, testing, commissioning and end-user training.

In accordance with FAR 52.211-6, the Manufacturer and/or Stock Numbers are listed for reference only. Offerors may provide a solution that has differing line items so long as the statement of work is satisfied. In other words, vendors are not restricted to matching the line items directly.

The contractor must provide catalog information and specifications to prove that their product meets the minimum requirements of the Government. Failure to provide the information will result in the quote not being considered for an award.

GREY MARKET ITEMS: The Vendor shall be an Original Equipment Manufacturer (OEM) authorized dealer, authorized distributor, or authorized reseller for the proposed equipment/system such that the OEM warranty and service are provided and maintained by the OEM. The vendor shall provide new items ONLY; no remanufactured or "grey market" items. All items must be covered by the manufacturer's warranty. The offeror shall provide evidence of its authority to distribute the proposed equipment/system at the time of submission of its quote/offer. Please note that such evidence is subject to verification by the Contracting Officer at his/her discretion.

Contractor shall provide a Turn-Key Solution and supply All Equipment, Parts, Supplies, Accessories, Labor, Licensing, Drawings, Training, and Commissioning for a Security Camera System for the Sioux Falls VA Health Care System (SFVAHCS) Pharmacy location. The Sioux Falls VA Health Care System is located at 2501 W. 22nd Street, Sioux Falls SD 57105.

2.0 QUOTE REQUIREMENTS

- a) The quote should include drawing configurations and layout.
- b) The quote should include a bill of materials with product subtotal, labor/installation line item, and total cost for each deliverable separately.
- c) New and Unused. All goods shall be new and unused, produced from current production components.
- d) Environmental Considerations. All components should comply with current federal and agency sustainability requirements. In accordance with Executive Orders 13101 and 13123, preference will be given to products with beneficial environmental characteristics. This may include recycled content, limits on volatile organic compounds (VOC) emissions, energy efficiency, recyclability, rapidly renewable, and bio-based materials. Quotes shall include information on the environmental characteristics of offered products, including certifications, if any. (If required)
- e) Please identify contract(s) and any Orders awarded within the past twelve (12) months similar to the requirement and magnitude of this requirement and include a contract or job point of contact that the VA could contact to evaluate past performance. Offerors are to include the following information for each contract or sub-contract.

- 1) Name, email address and telephone number of the contracting officer.
- 2) Name, email address and telephone of program manager or contracting officer's technical representative.
- 3) Dates of contract performance.

3.0 PROJECT REQUIREMENTS

Contractor shall provide a Turn-Key Solution and supply all **Equipment, Parts, Supplies, Accessories, Labor, Licensing, Drawings, Training, and Commissioning for the Milestone Corporate Xprotect VMS (Version 2014 or newer) to include the Base Software Licensing, Management Server & P2000 Integration Licensing.** Offeror must provide certification of capability to meet the compatibility/integration with Milestone and P2000 as part of their proposal.

To include the following:

- a) Recording Server(s) and Storage to meet the requirement of a minimum of 60 days of continuous (30 FPS – 24/7) retention. The Storage system must be capable of being expanded. Servers shall be **Brand Name Only "Dell"**.
 - a. - The Government will provide space within the Server Room for up to 3 additional servers. UPS, KVM, Rack, and PDU are not required to be provided by the contractor
 - b. -Video Recording Capability is Required
 - c. -Audio Recording Capability is Not Required
- b) Recording Servers shall be RAID 5 or Better with scalable storage with capability to double the size of the recorded storage space
- c) 24-Port Cisco POE Switch(s) with 10GB modules to meet the camera coverage requirements. IT will require this as an extension of their network
- d) Patch Panels (Panduit) are required for all communication room data drops. Labeling shall be accomplished at the time of installation. Layout shall be approved by VA IT prior to installation.
- e) All data cabling shall be Cat 6 with a "Purple" colored jacket
- f) (2) A/V door stations with VOIP wall-mount phone for Pharmacy visitor door control.
- g) Minimum of 1 Camera for each of the pharmacy booths (B89C, B89D, B89E) to include the Pharmacy Pick Up Window between B89A and B89B
- h) Contractor shall provide a minimum of 5 monitors to display up to 16 feeds on each monitor. In the Main Security Operations Office located just off the Main Lobby of Building 5
- i) Contractor shall provide the capability of up to 5 Workstations. 4 each for Security and 1 each Stand Alone for Mental Health Nurse Station
- j) Monitors shall be brand name or equal HD 1280P and be a minimum of 40" Diagonal Viewing not exceed 50" Diagonal Viewing
- k) Camera coverage for all areas of the Pharmacy (B89, B92, B92B, B93, B93A, B93B) to include the Vault Area (B94) (A minimum of 3 of cameras must be multi-lens cameras – 4 lens' each)
- l) Vault area must have sufficient camera coverage to ensure there is no view obstructions on 2 images at all times. (i.e. when a pharmacist body is blocking the view of an image, there needs to be at least 2 other images without the view obstruction)
- m) Camera coverage shall be provided for the entire Main Lobby, Pharmacy Waiting Area (B76, B77, and C20), Main Hallway (C03 and C04) from Main Lobby to the Main Elevators on the Ground Floor of Building 5
- n) Camera coverage shall be provided for the Main Elevator Lobbies for Building 5 Ground Floor (C30), 1st Floor, 2nd Floor, 3rd Floor, and 4th Floor
- o) MH2 Camera System must be stand alone with **NO** recording capability per Patient Privacy Requirements
 1. Each Patient Room – Patient Common-areas such as hallways and within the Lockdown Unit on Building 1 MH2
 2. Cameras in MH2 must be tamper proof and Non- Grip for Patient Safety

3. Cameras in Patient Rooms must have IR capability for viewing in low light.
- p) (11) Fish-eye Cameras for all eleven med storage rooms
 - q) 24-Port Cisco POE Switches with 10GB modules.
 - r) Cameras require only 1 Viewing angle within areas not in a specified med room and must be positioned in a way not to view the hallways to protect Patient Privacy.
 - s) Cameras must be P-Series (or higher) Axis branded or comparable, pre-approved cameras (by the Sioux Falls VAHCS) with minimum 1080p resolution except for the pharmacy vault, narcotics cabinet, and service window. The pharmacy vault, narcotics cabinet, and service window in the Pharmacy must be a minimum of 5mp or 4k resolution. Med rooms will require fish eye cameras meeting minimum resolutions.
 - t) All cameras will be compatible with Milestone software currently used by the VA and the contractor will provide any licensing needed for the volume of cameras installed.
 - u) Cameras installed in the Pharmacy Must meet requirement of a Tamper-proof Camera System. A tamper-proof camera system that records all activity is required in the pharmacy or facility vaults and all storage areas containing working stocks of controlled substances. Either the Police Service or Pharmacy must monitor these camera systems. NOTE: The standards for digital video systems are included in the VA Security Handbook (VA Handbook 0730). attached
 - v) Contractor shall include/integrate any existing camera locations that are not being replaced as part of this contract.
 - w) Plenum Rated Cables: Type and Installation Must Meet NFPA Requirements.
 - x) System **MUST** Integrate with Milestone VMS and P2000. This includes but is not limited to floor-plan mapping and P2000 point linking (i.e. card reader to a respective camera). All future VMS expansions can be integrated/configured as required.
 - y) Provide a turn-key solution including the electrical installation, programming, testing, commissioning and end-user training.
 - z) Contractor Shall integrate existing cameras feeds from Building 38 and Building 5 that are not being replaced as part of this project.
 - aa) Proposed Cameras must be Business/Industrial grade (Residential/Home use cameras/system are NOT authorized).
 - a. Mental Health Area Cameras must be tamper proof and intended for institutions to allow for Patient Safety and protection of the equipment.
 - bb) Contractor shall integrate existing cameras feeds from Building 38 and Building 5 that are not being replaced as part of this project.

4.0 CONTRACTOR REQUIREMENTS

- a) **Contractor will be required to prove a minimum of 3 years' experience in Security and Surveillance System Installation and Integration. Contractor shall be Bonded and Insured to the minimum required by Law and Regulation.**
- b) Contractor must be capable to provide Telephone Service Support within 4 hours and On-Site Support within 24 hours of notification. Service Contractor must reside in a Service area which will meet the 24 hours on site support requirement.

5.0 DELIVERY/INSTALLATION

1. Delivery [FOB Destination], (all shipping and handling charges shall be paid by the contractor) installation/configuration of all solutions must be managed and completed in coordination with facility schedule to ensure timely government occupancy and smooth facility operations. 2. Offeror to remove all boxes and any excess salvage from the VA grounds and dispose at contractor cost. All equipment components should be standard recycled content. See attached layout for guidance.
 - Push distance from the parking lot to the install site is approximately 350 feet
 - Access to Warehouse loading dock is available for unloading of material only

Period of Performance shall not exceed **120 days** after award.

- a. The installation day/date shall be coordinated with the Contracting Officer Representative of Sioux Falls.
 - b. Installation shall be performed during Normal Business Hours 8:00 A.M. – 4:30 P.M Monday – Friday excluding Federally Recognized Holidays.
 - c. Vendor is responsible for notifying POC in advance of arrival and departure, providing review of all product and site conditions before signing off. Work is to be performed between 8:00am and 4:00pm weekdays unless specifically coordinated otherwise
 - d. Trucks cannot be left unattended and must be removed from unloading area after unloading
 - e. Drop shipping is not acceptable. All deliveries must be received and handled by installers.
- **Installation Requirement.** Completion of the installation requirement will require the following minimal tasks:
 - I. The Sioux Falls VAHCS will not provide equipment, tools or labor to assist in furniture deliveries. All necessary equipment and manpower must be included in quote.
 - II. The Sioux Falls VAHCS will not provide on-site storage for furniture requirements for the Sioux Falls project unless negotiated in the best interest of the VA. Necessary storage must be included in proposal.
 - III. Any damage to the Sioux Falls VAHCS facility incurred through the installation process must be repaired within 30 days at the vendor's expense.
 - IV. Deliveries must be scheduled through the POC before installation.
 - V. Delivery, staging, and installation/configuration of the camera system for the specified area (including all fasteners and fixtures required for assembly), and warranty service that will result in

- a turn-key furniture solution in accordance with the final camera system design (subject to final working drawings).
- VI. Meet all incoming delivery vehicles at the building entrance, unload deliveries, check for damages, and move them to the appropriate areas. Areas will be clear and carpeted.
 - VII. The contractor must arrange delivery to the installation site location in accordance with the Installation Schedule.
 - VIII. During Installation the Contractor shall provide when directed by the Government, HEPA Carts or Air Filtration.
 - IX. Contractor shall not remove more than 2 ceiling tiles at one time without approval of the Government.
 - X. Complete installation of camera system in accordance with Government approved manufacturer specific drawings and specifications. Any missing or damaged products must be replaced IMMEDIATELY.
 - XI. The contractor will be responsible for any damage to the building which occurs during delivery and installation. It is incumbent upon the successful contractor to identify any existing damage to the building by means of a pre-installation and delivery walk-thru.
 - XII. The contractor shall clean up and dispose of waste materials or rubbish in accordance with this paragraph and all applicable federal, state, and local regulations, standards, codes and laws. The contractor shall keep the job site, including staging and storage areas used by the contractor, free from accumulations of waste material or rubbish. Prior to completion of the work, the contractor shall remove from the vicinity of the work all shipping containers, packing, rubbish, unused materials, and other like material, belonging to the contractor or used under the contractor's direction.
 - XIII. Provide on-site management, coordination and technical assistance by a project manager working with the Government representative throughout the installation phase.
 - XIV. The contractor will be responsible for confining its crew and work to the designated project areas. The contractor will also be responsible for ensuring that the installation personnel are identifiable.
 - XV. Contractor is responsible for ensuring that the camera system is mated to building utilities and is fully functional.

Installation must be performed by a licensed and bonded installation company, including any proprietary certifications necessary to maintain product warranties. Contractor will be required to prove a minimum of 3 years' experience in Security and Surveillance System Installation and Integration. Contractor shall be Bonded and Insured to the minimum required by Law and Regulation.

6.0 GOVERNMENT RESPONSIBILITY

Government Responsibilities

- a) The Government will be responsible for electrical connections between the building source and the furniture infeed.
- b) The Government will be responsible for pulling and terminating phone/data lines.

An itemized quote must be included with your response. Your technical solution must provide information in sufficient detail. The Government will make no assumptions.

SECTION C - CONTRACT CLAUSES

C.1 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (JAN 2017)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) *Invoice.*

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT)*. If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount*. In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments*. If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest*.

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions*. The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title*. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty*. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability*. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances*. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts*. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence*. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

(1) The schedule of supplies/services.

(2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;

(3) The clause at 52.212-5.

(4) Addenda to this solicitation or contract, including any license agreements for computer software.

(5) Solicitation provisions if this is a solicitation.

(6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments

(9) The specification.

(t) *System for Award Management (SAM)*.

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in

the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) *Unauthorized Obligations.*

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) *Incorporation by reference.* The Contractor's representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document;

(iv) The business has been verified for ownership and control pursuant to 38 CFR 74 and is so listed in the Vendor Information Pages database, (<https://www.vip.vetbiz.gov>); and

(v) The business will comply with subcontracting limitations in 13 CFR 125.6, as applicable

(2) “Service-disabled veteran” means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

SECTION E - SOLICITATION PROVISIONS

- (7) "Remit to" address, if different than mailing address;
- (8) A completed copy of the representations and certifications at FAR 52.212-3 (see FAR 52.212-3(b) for those representations and certifications that the offeror shall complete electronically);
- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall

be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during pre-award testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions, including alternative line items (provided that the alternative line items are consistent with subpart 4.10 of the Federal Acquisition Regulation), or alternative commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers.

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

- (6) Reasonable responses to relevant questions posed by the debriefed offeror as to whether source-selection procedures set forth in the solicitation, applicable regulations, and other applicable authorities were followed by the agency.

(End of Provision)

The above evaluation factors are listed in descending order of importance. Evaluation factors other than cost or price, when combined, are significantly more important than cost or price. Technical Capabilities are significantly more important than price.

Factor 1 – Technical Capability

Security Camera System proposal to meet the requirements of the Statement of Work/Functional Performance Specifications.

Evaluation Criteria for this acquisition are listed in the solicitation and include multiple non-price factors. The Technical Capability factor will be considered for its strengths, weaknesses and deficiencies.

Factor 2 – Price

Evaluation factors other than cost or price, when combined, are more important than price. The price will be evaluated by the Contracting Officer to determine reasonableness and whether the price realistically supports the requirements of the solicitation. One or more of the following techniques will be used to ensure a fair and reasonable price:

1. Comparison of proposed competitive prices received in response to the solicitation.
2. Comparison of proposed prices with the independent government estimate.
3. Comparison of proposed prices with available historical information.

Factor 3 – Past Performance

Past performance will be evaluated to assess the historical facts of the offerors' work experience, the quality and relevance of that experience, and how well they performed under other contracts. The Contracting Officer will consider references from both inside or outside the federal government, so long as the performance is recent and relevant.

If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. (B) *The taxpayer is delinquent in making payment.* A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.

(ii) *Examples.*

(A) The taxpayer has received a statutory notice of deficiency, under I.R.C. Sec. 6212, which entitles the taxpayer to seek Tax Court review of a proposed tax deficiency.
