B.4 STATEMENT OF WORK

Regulated Medical Waste Removal

For

Central Texas Veterans HealthCare System (CTVHS) Temple and Waco, TX Facilities

I. GENERAL REQUIREMENTS:

- A. The Contractor shall provide all personnel, equipment, tools, materials, supplies, containers, transportation/vehicles, supervision, and other items and services necessary to perform Regulated Medical Waste Removal, Treatment, and Final Disposal in the most economical fashion for the Central Texas Veterans Healthcare System (CTVHS).
- B. **Contractor shall provide** Regulated Medical Waste (RMW) handling, removal, transportation, final disposal of waste, and/or treatment **as** requested in the most economical fashion to the **CTVHS**.
- C. The Contractor shall be responsible for ensuring their proposed service will work effectively in achieving the performance specified. Contractor pricing shall be per **container**. An attached listing provides identification of currently utilized medical waste streams requiring service at each site.
- D. System and/or equipment procedures designed by the Contractor shall ensure the economical method for separation and preparation of waste streams for removal through final disposal.
- E. All medical waste must be disposed of in conjunction with current and existing EPA, OSHA, JCAHO, DOT State of Texas, TCEQ, and Local and Federal Regulation and requirements.

II. SPECIFIC REQUIREMENTS (Specifications):

- A. RMW services will be provided for all the facilities within Veterans Health Administration located within or associated with CTVHS. CTVHS reserves the right to add or subtract service locations based on the need of service.
- B. Contractor shall furnish all necessary transportation, labor, supervision, supplies, and equipment to pick-up and dispose of regulated medical waste that includes sharps (hypodermic needles/syringe with attached needles, scalpel blades, razor blades and disposable razors, Pasteur pipettes, broken glass from laboratories, extracted teeth), blood (liquid or semi liquid, contaminated items that would release blood in a liquid or semi liquid state if compressed, items caked in dried blood and are capable of releasing these materials during handling), pathological waste (include but not limited to human materials removed during surgery, autopsy, or biopsy, including body parts, tissues, organs, and bulk blood and body fluids, laboratory specimens of blood and tissue after completion of laboratory examination, anatomical remains, research animals, antineoplastic and chemotherapeutic waste, microbiological (cultures, discarded live and attenuated vaccines, disposable culture dishes, disposable devices used to transfer, inoculate, and mix cultures), and research carcasses.
- C. Contractor shall furnish all storage and all packing and shipping containers. Contractor will maintain an adequate number of packing and shipping containers. Contractor is responsible for the repair or maintenance of storage containers such as trailer or special equipment needed to protect regulated waste. These packing and shipping containers are used for transporting the medical waste to an EPA approved disposal site, for proper destruction. All packing and shipping containers, bags, and boxes shall be provided by contractor and shall meet or exceed current Texas DOT (TXDOT) regulations and standards.
- D. Contractor shall provide refrigerated storage trailer for regulated waste for the Temple Hospital location.
- E. Containers used at the CTVHS will be the regular cardboard and plastic type containers.
- F. An EPA approved manifest shall be provided to each location when medical wastes are picked up by the Contractor.
- G. Within 45 calendar days of pickup, Contractor shall submit a certificate of destruction of the medical waste destroyed in accordance with EPA regulations. The report shall be prepared for each location and provided to each location. **Please note that payment for services will not be rendered until official certificate of destruction is provided.**
- H. Upon request by the CTVHS, Contractor agrees to provide in-service training to CTVHS personnel involved in packing and handling the medical waste and do periodic

medical waste stream analysis. Each analysis will be provided to the Contractor will be provided to the Contracting Officer Representative (COR). The objective of this analysis will be for the Contractor to assist the CTVHS in reducing the regulated medical waste (RMW) generated.

- I. Should the Contractor ever detect radioactivity in any medical waste, or other hazardous chemicals, Contractor shall immediately report the finding to the COR and work directly with the CTVHS regarding the security, holding or return of any packing and shipping container from which radioactivity or hazardous chemical waste was found.
- J. The Contractor shall provide sufficient "Incineration" labels to the CTVHS. These labels will be affixed to the container that contains pathological and antineoplastic and chemotherapy wastes to ensure that this waste is properly incinerated. Antineoplastic and chemotherapy waste will be placed in designated yellow bags labeled for that purpose. Yellow bags will be provided by the CTVHS.
- K. The Contractor shall provide sufficient "barcode" labels to the CTVHS. These labels will be affixed to each container to ensure proper tracking.
- L. Payment to the Contractor for services rendered will not be initiated until a signed manifest is provided ensuring that RMW was properly disposed.
- M. The contractor shall submit completed manifest and burn sheets along with draft monthly invoices to:

- N. The Contractor shall provide CTVHS with red liner biohazard bags, appropriate packaging labels and cardboard boxes. The contractor shall ensure storage, pick up, transportation and disposals are performed in accordance with all local, state, and federal laws, regulations and codes. The

Contractor shall provide documentation of compliance when requested. The Contractor shall furnish all required controlled documents to the COR and the respective facility promptly after final disposal.

- O. The Contractor shall coordinate marking, packaging, and provide proof of disposition for medical waste, lab specimen waste, antineoplastic drugs, and pathological waste, in strict accordance with all local, state, and federal laws. The Contractor shall provide necessary documentation to ensure regulatory compliance with Joint Commission on Accreditation of Healthcare Organizations (JCAHO), OSHA, CDC, etc. related to items under this contract.
- P. Contractor shall provide reusable sharps containers, container outer cabinets, equipment and proper vehicles as legally required, for the transportation of sharps waste to disposal site(s). Contractor shall use and operate proper vehicles conforming to all safety codes of the State of Texas and all other governmental agencies requiring conformity to their codes of safety. Contractor vehicles shall be operated only by licensed operators and only on paved roadways, unless otherwise authorized by the Contracting Officer Representative (COR) or authorized designee.
- Q. Contractor shall insure that disposal of sharps waste is by **LEGAL** means as the law may dictate and require for disposal of such waste. The Contractor shall provide COR with documented proof that transportation and disposal of such waste is in conformity and in accordance with all applicable legal requirements. Proof of all legally required permits, licenses, insurance, manifests or any other documentation so required by law, shall be provided and furnished to the COR.
- R. It shall be the responsibility of the Contractor to notify the COR of any change or alteration to Contractor's permits and licenses for facilities, (including but not limited to disposal sites), or for any change in status which may affect Contractor's performance and particular in performance of obligations under this contractual agreement.
- S. The Contractor's services, as required by this contract, shall be in accordance with all Department of Transportation (DOT), Environmental Protection Agency (EPA), Department of Health (DOH), Department of Environmental Conservation (DEC), Food and Drug Administration (FDA) and applicable Federal, State and Municipal governmental regulations and codes that are applicable, but different in scope, are to be all complied with and shall be strictly adhered to, shall include:
 - 1. Transporter must provide water-resistant labeling on all containers of regulated waste with the following information: Name of Transporter or immediate handler and State permit or identification number of the transporter.
 - 2. **NO intermediate handlers or subcontracting of collection and/or transportation is allowed without obtaining prior approval from the COR.**
 - 3. Contractor shall sign, date, and furnish a copy of the manifest, prior to any medical regulated waste leaving the pickup sites. Contractor shall certify that the manifest data matches the load to be removed, deliver the waste to an authorized facility and sign the manifest to verify that medical waste has been delivered. Contractor shall also maintain a copy of the manifest

for their records, return all remaining copies of the manifest to the generator, assuring final disposal.

4. The CTVHS reserves the right to inspect Contractor's facility site(s), equipment, and disposal facilities at any time. All permits, including disposal permits, licenses and insurance of the disposal site(s) shall be included in the proposal submitted. Contractor shall submit annually, updated documents as they expire.
5. Contractor shall provide all necessary equipment, manpower, transportation and reusable container replacements to perform the service of collection, removal and disposal of sharps waste from the seven locations at regularly scheduled intervals.
6. Contractor shall have demonstrated ability to convert all CTVHS locations to their services immediately after award of contract.
7. After contract award, the Contractor shall be required to provide an annual site visit of their respective disposal/recycling sites, to verify capability and compliance. The contractor shall provide proper handling, packaging and segregation training at all locations at least annually.

III. CONTRACTOR SUBMITTALS:

- A. Contractor shall have sufficient backup equipment and manpower to perform contractual obligation under adverse or emergency conditions and such backup equipment and manpower shall be listed on the equipment and manpower list submitted with proposal.
- B. Contractor shall have and submit with proposal, a listing of disposal site(s), backup disposal site(s), along with copy of permits. Contractor shall submit backup disposal site(s) permits annually thereafter. Contractor's pick up schedules shall be coordinated with COR.
- C. Contractor shall supply documentation assuring that all its employees are trained according to applicable Federal, State and local regulations and supply training updates to COR.

IV. ID BADGES, SIGN-IN, PARKING AND SMOKING:

- A. All Contractor personnel shall be required to wear an identification badge while on Government facility grounds displaying the picture and name of the individual and the name of the company represented.
- B. It is the responsibility of contractor personnel to park only in designated parking areas. The VA will not validate nor make reimbursement for parking violations of the contractor's personnel under any circumstances.
- C. Smoking, tobacco use or e-cigarettes is not permitted within or around VA Healthcare System facilities, except in designated smoking areas.

V. VEHICLE SECURITY AND SAFETY:

- A. Contractor vehicles shall be clean and in good working order.
- B. Spills, seepage, etc. will be cleaned by the contractor prior to leaving facility. Spill kits shall be in each vehicle to ensure immediate cleaning of spills.
- C. The Contractor shall comply with the speed limit set by the Government facility. Should Contractor personnel receive a citation for parking or other vehicular infractions from VA Security personnel, the offenses will be handled in Federal Court, as they are Federal offenses.

VI. NATIONAL HOLIDAYS:

- A. Contractor shall schedule services based on mutually agreeable time between the federal government and the contractor; within normal business hours, and not on weekends or holidays.
- B. The following national holidays are observed:

- C. Also included would be any day specifically declared by the President of the United States to be a National Holiday.
- D. When a holiday falls on a Sunday, the following Monday shall be observed as a legal holiday by U.S. Government agencies. When a holiday falls on a Saturday, the preceding Friday shall be observed as a legal holiday.
- E. It is understood and agreed between the Government and the Contractor that observance of such days by Government personnel shall not otherwise be a reason for an additional period of performance, or entitlement of compensation. In the event the Contractor's personnel work during the holiday, they may be reimbursed by the Contractor, however, no form of holiday or

other premium compensation will be reimbursed either as a direct or indirect cost, other than their normal compensation for the time worked.

VII. EQUIPMENT MAINTENANCE:

- A. The contractor shall maintain all contractor provided containers ensuring they are free of unpleasant odors, dirt, debris, and pests.
- B. All containers must remain in good, workable condition. They shall remain easily accessible to customers.
- C. The contractor shall perform all cleaning, painting, repair and other maintenance tasks off-site.

VIII. PERSONNEL REQUIREMENTS:

- A. The Contractor shall designate and provide name(s) and phone numbers of contact person (s), and a backup, as representatives of the Contractor. The Contractor shall provide qualified employees who will conduct and/or supervise the removal and pickup of all regulated sharps waste from all CTVHS locations.
- B. Contractor shall ensure their personnel working at the facilities specified herein; possess basic proficiency in spoken and written English. Contractor personnel must wear identifying uniforms and employee badges.
- C. All conduct of contract personnel shall be respectable and sensitive to patients, visitors and VA Personnel.

IX. QUALITY CONTROL:

- A. The contractor shall develop and maintain a quality control program to ensure refuse services are performed in accordance with commonly accepted commercial practices.
- B. The contractor shall develop and implement procedures to identify, prevent, and ensure non-recurrence of defective service.
- C. The contractor shall provide sample of their quality control plan to the Contracting Officer with their proposal.

X. QUALITY ASSURANCE:

- A. The government will periodically evaluate the contractor's performance by appointing a COR (Contracting Officer's Representative) to monitor performance to ensure services are received.
- B. The COR will evaluate the contractor's performance through intermittent on-site inspections of the contractor's quality control program and complaints from customer personnel.
- C. The government may inspect each task as completed or increase the number of quality control inspections if deemed appropriate because of repeated failures discovered during quality control inspections or because of repeated customer complaints.
- D. As stated above, the contractor shall be responsible for their own internal Quality Control Program. The Government will perform surveillance of the contractor's performance using this Performance Work Statement and the Performance Requirements Summary (see Technical Exhibit 1) below to determine if the contractor exceeds, meets, or does not meet these standards. The fact that the government is performing surveillance of the contractor's performance does not in any way relieve the contractor from performing their own surveillance and maintaining acceptable quality levels.

a. **Performance Requirements Summary Matrix:**

The government shall use these standards to determine contractor performance and shall compare contractor performance to the Acceptable Quality Level (AQL).

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. SECTION E - SOLICITATION PROVISIONS

Evaluation of options shall not obligate the Government to exercise the option(s). *Evaluation of options under FAR 52.217-8 will be accomplished by using the prices offered for the last option period to determine the price for a 6-month option period, which will be added to the base and other option years to arrive at the total price.* Evaluation of options will not obligate the Government to exercise the option(s)."

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.

3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the Wage and Hour Division, U.S. Department of Labor, for review (See 29 CFR 4.6(b)(2)(ii)).

4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.

5) The contracting officer transmits the Wage and Hour decision to the contractor.

6) The contractor informs the affected employees.

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the "Service Contract Act Directory of Occupations" (the Directory) should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination.
