1. SCOPE OF WORK:

The Veterans Health Administration (VHA) Equipment Life Cycle Management (ELCM) Program identified Fluid Warming Units as a candidate for VA-wide (otherwise referred to as “national”) single award Requirements contract. Fluid Warming Units are designed for in-line heating of banked blood and blood products from about 39.2 °F to near body temperature (e.g., 95 to 98.6°F) before infusion. They are used to minimize adverse thermal reactions in the patient. Fluid warming units are also used to heat irrigation solutions for use in arthroscopy, laparoscopy, and other procedures.

The Contractor must demonstrate the ability to meet all requirements for the solicitation. The objective is to provide Fluid Warming Units to be used by clinicians throughout the VA medical centers and facilities. The period of performance is for one (1) 12 month base period with two (2) twelve (12) month option periods.

2. REQUIREMENT:

This requirement will be IAW FAR clause 52.211-6, “Brand Name or Equal” which requires that the offeror indicate each product that is being offered as an “equal” product to the enFlow® brand. For each equal product, the offeror must include a description reflecting the characteristics and level of quality that will satisfy the salient physical, functional, or performance characteristics of the equal product(s) specified in the solicitation. The offeror also must clearly identify the item by brand name (if any) and make/model number. Finally, the offeror must include descriptive literature, such as illustrations, drawings, or a clear reference to previously furnished descriptive data or information available to the contracting officer, and clearly describe any modifications it plans to make to a product to make it conform to the solicitation requirements.
