2. Brief Description of Supplies/ Services required and the intended use/Estimated Amount:

The Erie VA (562) is constructing a new Dental Clinic to provide a modern facility to better serve Veteran medical needs. This contract is for the purchase, delivery and installation of Planmeca name brand intraoral and 3D panoramic imaging equipment for 5 new dental operatories and panoramic exam room on the third floor of the new Dental Clinic site located at 135 East 38 Street, Erie PA, 16504. The estimated value of the proposed action is [REDACTED]

This procurement is for the purchase, delivery and installation of one Planmeca brand name (1) 3D panoramic dental x-ray machine with accessories and software and five (5) Planeca brand name ProX intraoral dental x-ray machines with accessories and software for the Erie VAMC.

3. Unique characteristics that limit availability to only one source, with the reason no other supplies or services can be used:

The brand name Planmeca ProMax 3D Mid CBCT unit X-ray (Panoramic) and Planmeca ProX Intra-oral X-ray Units have unique qualifications that are being requested. The equipment will be able to maintain current patient images and patient records currently being utilized in the Erie VAMC's Dental Clinic. Loss of this continuity of care with existing patient images would cause significant delays in patient care, increased costs due to the need for repeat x-rays and patient safety concerns. At the present time, the staff in the Erie VAMC's dental clinic is already trained and proficient in the use of this brand of equipment. Use of this specific equipment would also significantly decrease the training requirements, costs, and assure a smooth transition for patient care services.

Additionally, if the Erie VAMC would pursue other brands, staff education will need to be conducted and re-educating of staff would prevent a smooth transition thus creating a significant impact on patient care. Continuity and familiarity for these units are necessary to continue to provide uninterrupted patient care. While there are other brands of imaging equipment similar to Planmeca, utilities have already been installed in the new clinic area and casework specific to this equipment size has already been planned. Any changes to the clinic area or installed utilities would be at an unnecessary additional cost to the government at this time.

4. Description of market research conducted and results or statement why it was not conducted:

Planmeca, a large business, provides the requested items. Federal Procurement Data System research indicates that Planmeca has recently worked through 3 Service Disabled Veteran Owned Small Business vendors. As such, this is a brand-name justification, and the requirement will be competed amongst authorized SDVOSB vendors.
