1.0 Summary of Requirement

Hunter Holmes McGuire VA Medical Center is seeking to replace its end of life cycle electronic vertical filing system for patient charts with a similar system to store, secure, and electronically cycle through rows of records with the capability to operate independently without power in the event of loss of power.

2.0 Scope

The Contractor shall be required to furnish all items, to include but not limited to, project management, labor, removal and disposal, equipment, materials, travel and any incidentals required to satisfy the requirements of this Statement of Work. The Contractor shall also be responsible for timely delivery, training, and phased site deployment as needed to ensure the successful completion of the tasks as outlined in this Statement of Work.

3.0 Description of Work

The Contractor shall be required to furnish all items, to include but not limited to, project management, coordination with customer appointed point of contact, labor, equipment, materials, travel, loading/unloading, crating/uncrating, site clean-up and any incidentals required to deliver and provide deployment of a filing system change out in the clinical unit of the Radiation Oncology within Hunter Holmes McGuire Richmond VA Medical Center. The contractor shall be required to provide Clinical Staff Training and a train the trainer course. The contractor shall also be required to remove and dispose of existing equipment as new equipment is being phased in with no disruption to the clinical environment and treatment of Radiation Oncology patients potentially leading to working in off-hour shifts. The contractor may be required to provide final electrical hookup connections from the unit motor to the electrical disconnect.

3.1 Vertical Carousel Filing System Requirements:

At a minimum the offered equipment shall possess the following characteristics to meet the Minimum needs of the Government:

3.1.1 Motorized Vertical Carousel Filing System

Quantity: 1

U/I: Each

- a. Contractor must provide all tools and rental equipment required to remove and dispose of the existing carousel which will be removed from the Hunter Holmes McGuire grounds for disposal at the vendor's arrangement.
- b. Maximum external dimensions of the new unit are not to exceed 56 inches deep, 129 inches wide, and 114 inches tall and the unit must be self-contained and not require any building modifications to install (i.e. subfloor) except for minor modification of the existing drop ceiling and rerouting conduit/electrical for power supply.
- c. Unit will come with a fixed seated work counter with ADA compliance kit at 29.5" inches which allows ergonomic access to stored goods.
- d. Unit must provide a manual drive crank capable of moving the carriers in case of electric outage for easy access to content within the unit.
- e. Computer Interface – Up and Down keys for manual rotation (carrier selection), 3-digit LED shelf level display, numeric key pad for carrier selection by shortest route, programmable carrier offset, start/restart, stop interrupt buttons, e-stop, system error indicator. Key board to be mounted into posting table.
- f. Unit will offer a manual lockable door for data security.
- g. A minimum quantity of 15 letter sized lateral carriers of approximately 11 inches high, 115 inches long, and 13 inches deep.

- h. Model shall have self- balancing design such that unit will not jam, tilt or skew, or otherwise become inoperable due to heavy shelves, empty shelves or uneven loading.
- i. The unit shall have an automatic on/off interior task lighting integrated into the unit.
- j. Vertical Carousels must have a standard manual override that can be operated with the door open, so parts can be located using “drive and view”, without having to know what carrier the part is stored on.
- k. Materials – This high density vertical system shall be of high quality steel construction with an automotive grade painted finish.
- l. Electrical – Unit to plug into existing 110-volt ceiling outlet or hard wired into the outlet.
- m. The contactor must ensure the equipment complies with DIN EN 15095 “Power-operated mobile racking and shelving, carousels and storage lifts” and has been tested and certified by TÜV (Technical Observation & Control), a USA NRTL and a Canadian CB.
- n. Factory must be certified ISO 9001.
- o. Manufacture must be certified ISO 14001.
- p. Workmanship – All workmanship shall comply with standard trade practices. The vendor will supply their own equipment to include, but not limited to, equipment for delivery, transporting within the facility, unloading, removal, installation, and clean up/packaging and crate disposal. The vendor will be responsible for all labor involved with the only exception(s) being movement of material currently stored on the unit to be removed and changes to the electrical system from the existing power supply into the facility power grid.
- q. Documentation – The contractor shall provide complete documentation, all manuals, drawings and schematics of installed equipment. The contractor shall provide all necessary information and software documentation, so that the government can program and repair the system independent of the contractor, after the government inspects, accepts and takes ownership of the equipment.
- r. Warranty – The contractor shall guarantee all workmanship, warranty all equipment, software and installation for a minimum period of 2 years.

4.0 Brand Name References

Any and all references to a brand name, model, marketing language or functionality pursuant to a particular manufacturer does not constitute a preference/desire of the Government for any one make or model over any other. The intent of the language contained herein is merely to communicate to industry as to the minimum needs of the Government in the most efficient means possible and does not represent the Governments preference.

5.0 Brand Name “or Equal” Submission Instructions

For consideration and evaluation of technical acceptability of any product proposed as an “or Equal”, the Offeror shall submit, with its offer, all technical data pertaining to the proposed as an equivalent, for consideration of technical acceptability. Offerors shall be responsible for demonstrating equivalency in a side by side comparison of technical data and shall address how each of the salient characteristics/minimum needs of the Government, as identified in this solicitation, have been met and/or exceeded. Any Offeror, failing to submit such supporting documentation, as required for an “or Equal” in accordance with this solicitation, shall not be considered. The Government will only review documentation as submitted by Offerors to determine technical acceptance and shall not be held responsible for researching any additional information beyond that information submitted by the Offeror.

6.0 Training

A. End-User Staff

The Contractor shall provide end-user staff and super users with training on proper care, use, operator level troubleshooting, cleaning and user maintenance functions. The selected vendor must provide initial education to clinical personnel at the site to ensure that a minimum of two Medical Support Assistants have received training. Initial education will include organized blocks of instruction, at minimum training sessions will be conducted onsite. A train-the-trainer class is required as well. The vendor will provide electronic training materials (handouts, visual aids, user assessment, etc.) and vendor staff to complete the training.

B. Service Technician Training (Gov't Personnel)

If available, the Government desires field service engineer training courses for Richmond VAMC assigned Biomedical Engineer/technician. The field service engineer school will provide the Biomedical Engineering with sufficient knowledge, keys, software, etc. to be able to perform all calibrations, repairs, tests, troubleshooting, etc. on the equipment. Training shall include access to any and all service manuals, and software for in-house maintenance capacity to service the equipment.

7.0 Trade/Removal

The contractor shall also be responsible for the removal and disposal of existing equipment being replaced with new equipment is being phased in. The contractor shall be required to remove the existing equipment from the facility. The equipment to be removed is identified as current Vertical File System and all associated peripherals not permanently affixed to the building interior located within the check in area of 1Z-122, Radiation Oncology department.

Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

(End of Provision)

ADDENDUM to FAR 52.212-2, Basis for Award

This is a competitive selection in which competing offers will be evaluated on the basis of Lowest Price Technically Acceptable.

The evaluation process shall proceed as follows.

1. Offers will be initially reviewed for compliance all terms and conditions required by the solicitation, to include but not limited, any established socio-economic set-asides, the requirements established within the SOW, Salient characteristics, and/or terms and conditions that establish minimum offer submission requirements. Offers received from firms that do not qualify under any established socio-economic set-aside identified in the solicitation, shall be rejected without review and without notification. Offers that comply with all terms of the solicitation will then move forward to the next step as detailed below. Offers that do not comply with all terms and conditions of this solicitation may be rejected for noncompliance.

2. Next, offers shall be ranked according to price, including option prices if applicable. An offeror's proposed price will be determined by multiplying the quantities identified in the pricing schedule by the proposed unit price for each contract line item to confirm the extended amount for each item. The extended amounts will be added together to determine the total evaluated price.

3. Next, the lowest priced offer shall be evaluated for technical acceptability. Technical acceptability shall be evaluated on a pass/fail basis considering whether the proposed product meets or exceeds the specifications identified in Section B of the delivery schedule.

4. If the lowest priced offer is determined technically acceptable, that offer represents the best value to the government and the evaluation process stops at this point. Award shall be made to that offeror without further consideration of any other offers.

5. If the lowest priced offer is not determined technically acceptable, the next lowest priced offer will be evaluated for technical acceptability and the process will continue in order by price until an offer is judged technically acceptable.

(9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
