Radio Repeater system VA Health Care System, Alexandria, LA

Scope

The VA Health Care System (VAHCS), Alexandria, LA requires Installation of a new Radio Repeater System in the 5th floor penthouse of building 7 and building 15(Day Room) at the VA Medical Center 2495 Shreveport hwy Pineville, La71360.

Anticipated Tasks

Furnish all labor, tools, materials, equipment and supervision necessary for the work to install Radio Repeater System. Emergency power is supplied and currently in place.

Install radio repeater system in building 7 penthouse.

Place repeater rack or holder in middle of room (see diagram) on wall nearest the road and run estimated 100ft runs of 3 times coax to south end of the room and secure antennas on exterior on building.

All work shall include proper hardware to mount and secure all coax and antennas.

Rack must be secured to floor and OSHA compliant.

Replace min 3 radio repeater systems in building 15.

Program system to integrate with the existing Motorola radios.

All programing must be completed by a certified tech.

Security and General Requirements

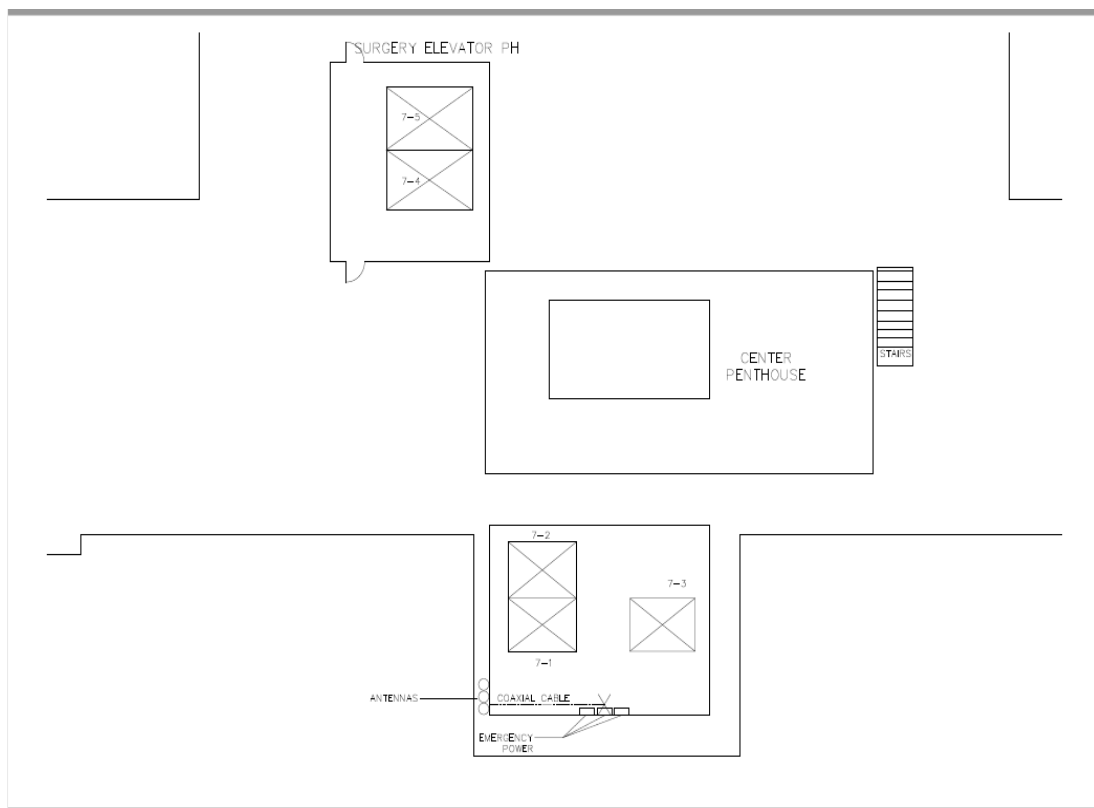

This solicitation includes **VAAR 852.219-10**. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. (b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.
