## **B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)**

This solicitation includes VAAR 852.219-10 VA Notice of Total Service- Disabled Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The contractor is required to cooperate fully and make available any records as may be required to enable the CO to assess the contractor's compliance with the limitations on subcontracting or percentage of work performance requirement.

## B.3 STATEMENT OF WORK

### INFECTIOUS WASTE DISPOSAL/SHARPS RECYCLING SERVICES-SAGINAW VAMC

**The following performance work statements apply to both Infectious Waste Disposal and Sharps Recycling Services Department of Transportation Requirements:** Transportation shall be in accordance with DOT HM-181. The Contractor shall also comply with state and local requirements, including obtaining all necessary permits, licenses and approvals.

**Federal Holidays:** The ten (10) holidays observed by the Federal Government are: New Year's Day, Martin Luther King Jr.'s Birthday, President's Day, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans Day, Thanksgiving Day and Christmas Day. Also, any other day specifically declared by the President of the United States to be a national holiday.

**Manifesting:** A waste manifest is required for the removal from the Government premises of all waste in this contract. Prospective contractors should provide a copy of their standard Sharps/Regulated Medical Waste Manifest for review by the Dept. of VA Contracting Officer to ensure compliance with State and Federal requirements. Reporting requirements should be In Accordance With (IAW) MDEQ-OWMRP-SWS\_MEDICAL\_WASTE\_MGT\_PLAN\_428276\_7 (attached file). The Contractor shall obtain and prepare all manifests. The pick-up manifests must be reviewed and signed by the appropriate VA Government official. Complete copies of all manifests shall be furnished to the COR. Manifests shall be submitted in such a manner as to comply with the timelines prescribed by the state and EPA regulations. Manifest must contain company information, to include name, telephone number, address, of Generator, primary transporter, secondary transporter, and treatment facility. Manifest must also include printed names of each company representative, signature, date, Department of Environmental Quality registration/permit number, number of containers collected, total weight of containers collected, and total waste and weight deposited/unloaded at the treatment facility.

**Permits and Responsibilities:** The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses and permits, and for complying with any applicable Federal, State, and Municipal laws, codes and regulations in conjunction with the work, this includes acquiring any installation listed in this contract. Contractor shall be summarily responsible for all damages to persons or property. Contractor shall take proper safety and health precautions to protect the work, the workers, the public and the property of others. The Contractor shall be responsible for all materials delivered and work performed until completion and acceptance of the entire work.

**Safety Requirements:** Contractor personnel and equipment shall comply with all applicable state, federal and local regulations. The Contractor agrees that his personnel and equipment are subject to safety inspections by Government personnel while on Federal property. The Contractor shall ensure that all personnel involved in the handling, repackaging, and transportation of the items listed herein shall be trained in the areas of spills, and general first aid procedures.

**Segregation of Infectious Wastes:** All items collected on this contract must be segregated and kept physically separate from any other items until the disposal site is reached. The items must be marked, so that they are readily identified as infectious waste throughout this period. In addition, the Contractor must ensure that there is a clear documented chain of custody for all items until disposal is accomplished.

**Spill Reporting Requirements:** The Contractor is responsible for reporting to the COR all spills, regardless of quantity, and all personnel exposures. Such reports shall first be reported by telephone immediately following the incident and shall be followed up in writing no later than seven (7) days after the initial report. When reporting a spill, the following information shall be furnished: (1) quantity spilled; (2) exact location of spill; (3) containment procedures initiated; (4) clean-up and disposal procedures; (5) personal injury involved; (6) assistance required; and (7) a narrative summarizing all on-scene visits made by local, state or federal officials.

**Spill Responsibility:** The Contractor is solely responsible for any and all spills or leaks during the performance of the contract. The Contractor agrees to clean up such spills or leaks to the satisfaction of the Government in a manner which satisfies the applicable state, federal and local laws and regulations, at no cost to the Government.

**The Joint Commission (TJC) Guidelines:** Where the contract does not require TJC accreditation or other regulatory requirements regarding worker competency, the Contractor must perform the required work in accordance with TJC standards. All contract employees working under this contract must be fully trained and competent to perform the job correctly and skillfully; with knowledge and skills required to successfully perform the work required.

## **SHARPS RECYCLING SERVICES**

### **Description/Specification / Work Statement**

**General:** The Contractor shall provide all labor/personnel, waste processing, equipment, supplies, packaging, storage, manifests, and transportation services necessary for the distribution, loading dock pickup, disposal of the waste, sterilization and replacement of sharps containers. This shall be done in accordance with all local, state and federal regulations, specifically Chapter 333-MI Public Health Code Part 138; OAC Chapter 3745-27; and all terms and conditions of this contract. All contents of the sharps containers are being discarded by the Government and are considered to be infectious waste. All sharps containers shall be of a vertical drop type and utilize existing Stericycle mounting brackets models C-02RES 0203, C04RES-04, and C-08-2004LR.

Replacement containers (equal to the quantity picked up for disposal/recycling) shall be furnished at no cost to the government. Pickup at the VAMC Saginaw, MI facility shall be weekly. Pickup at the Community Based Outpatient Clinics shall be bi-weekly (once every two weeks) or monthly, as determined by the Contracting Officers Representative (COR). If additional sharps are required for new VA Medical Clinics, **vendor shall provide sharps containers at the unit price as charged in vendor's response to the solicitation.**

The contractor must provide to the Government twelve (12) additional locking wall brackets for wall mounted sharps containers for extra inventory use to replace broken or to install for new location. The brackets shall only be billed as a onetime purchase for the initial twelve or for individual bracket provided to maintain the stock at twelve (12). Appropriate monthly charges must reflect actual costs for processing and disposal of regulated medical waste and sharps and recycling of sharps containers returned into service.

Recycled sharps containers shall be sterilized by autoclave methods.

**Other Reports:** For each pickup of sharps and medical waste, a signed manifest listing the quantity of containers by size and purpose (sharps, biohazard, cytotoxic) shall be completed by the Contractor and furnished to the COR. All waste pickup shall be listed and include the method of disposal. A monthly statement, quantifying the number of sharps containers, regulated medical waste and cytotoxic materials containers and itemized weight of contents shall be furnished to the VAMC Saginaw Industrial Hygienist (FMS). VA staff at the Saginaw VAMC are responsible for gathering and consolidating storage of used sharps containers, regulated medical waste (RMW) and Cytotoxic containers and placed at the HazMat Storage shed, Bldg. 1 loading dock. Vendor shall load used sharps, RMW & Cytotoxic for transport to vendor's processing depot and leave Clean sharps/RMW/Cytotoxic containers at Loading Dock. COR shall contact VA Housekeeping staff for storage of clean product. **Federal and State Regulations for Disposal process standards:**

- a. For the purpose of this contract, disposal can mean shredding, incineration, autoclave processing of infectious waste, IAW MDEQ Sections 13813(1) and 13817 of the Medical Waste Regulatory Act (MWRA), Part 138 of the Public Health Code, 1978 PA 368, as amended.
- b. Mere acceptance of the waste at a properly permitted treatment, storage, or disposal facility (TSDF) does not meet the definition of disposal under this contract. Documentation must be provided to prove that the disposal of all items (as defined in Other Reports above) has been accomplished.
- c. Infectious waste is defined as waste that includes, but is not limited to, cultures and stocks of infectious agents, pathological wastes, waste human blood and blood products, sharps used in patient and animal care, laboratory wastes and dialysis waste.
- d. Cytotoxic waste is defined as wastes that are generated from protean sources such as manufacturing waste, home care waste, contaminated materials from drug preparation and administration (expired medicines, left-over drugs, returned drugs, syringes, needles, gauzes, vials, packaging; samples such as urine, feces, and vomit from patients), containing hazardous amounts of the cytotoxic drugs and their metabolites which are genotoxic for 48 h to 1 week after drug administration.

## **INFECTIOUS WASTE DISPOSAL DESCRIPTION/SPECIFICATION/WORK STATEMENT**

**General:** The Contractor shall provide all labor/personnel, waste processing, equipment, supplies, packaging, manifests, and transportation services necessary for the disposal of the waste in accordance with all local, state, and federal regulations, specifically Chapter 333 – MI public Health Code Part 138 and all terms and conditions of this contract. All red-bagged items, regardless of their condition, are being discarded by the Government and are considered to be infectious waste. Pickup at the Saginaw VAMC and CBOCs shall be weekly or as determined by the Contracting Officer Representative (COR).

- b. Cytotoxic Waste: 52 BX/ (Current Cytotoxic Box volume is 16 gallons.) 6 boxes/containers are kept onsite at all time.

**Reports:**

- a. A signed manifest shall be completed by the Contractor and furnished to the COR. All waste pickup shall be listed.
- b. The Contractor shall prepare a Certificate of destruction completed at the Regulated Medical Waste Depot/place of incineration/disposal, and must include company name, quantity of waste to be destroyed, date, and signature verifying disposal. This certificate is to be submitted with the monthly Sharps and Regulated Medical Waste report and invoices. Any differences between the manifest and what was incinerated/autoclaved/disposed must be thoroughly described and documented. Attachments to the Certificate of Destruction can be used, if necessary.

**Cytotoxic Waste Containers:** Disposal containers (approx. 16- 25 gal.) shall be provided by the Contractor. These containers must be puncture resistant. They will be used exclusively for sharps boxes, gowns, gloves, etc., contaminated with cytotoxic waste. Bags of cytotoxic waste will be sealed by VA personnel before being collected and disposed of. The containers shall be clearly marked with labels, which state “CHEMOTHERAPY WASTE” and possess a biohazard symbol. *Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.
