PURPOSE:

To purchase a ManoScan HRM WS with Cart for use in Hospital Medicine provider rounds and treatment periods ensuring no adverse reactions to patients, and increasing more timely documentation of patient care/treatment.

GOAL:

Maintain proper charting and documentation, allowing providers to be flexible with the location of care with full access and use that a permanent workstation could provide.

1. Information System Officer, Information Protection: The contractor **will not** have access to VA Desktop computers they will not have access to online resources belonging to the government.
2. Privacy Officer: The Contractor **will not** have access to protected Patient Health Information (PHI) nor will they have capability of accessing patient information during the services provided to the VA and if removal of equipment from the VA is required, any memory storage device will remain in VA control and will not be removed from VA custody. All research data available for Contractor analysis is de-identified.
3. Records Manager:

 - 2. The Manometry Software must have the following features for diagnostic testing and research capabilities:
 - a. Displays anatomical model of esophagus with real time pressure profiles of UES, Esophageal Body and LES during data acquisition and impedance/conductance bolus transit simultaneously. Anatomical model depicts approximate or exact locations of all three areas of the esophagus referencing either distance from nares or distance from LES.
 - b. Displays isobaric contours for all pressure ranges to determine highest or lowest pressure inside contour plots
 - c. Smart Mouse feature provides specific point pressure measurement fully driven by user for customization and
 - 3. Onsite installation and all training must be performed onsite. Must be able to train on pharyngeal HRM including how to calculate the Pharyngeal Contractile Integral.
 - 4. Service Plan must cover all software upgrades, onsite training and technical support, and remote log in support capability for the length of the plan
 - 5. Manometry System must have video capability for simultaneous HRM and Fluoroscopy

Late quote or documentation will not be accepted. All questions, comments, or inquiries are to be submitted in writing to the Point of Contact, referenced above, prior to the closing of the solicitation.

I. Basis of Award

The Government intends to award a delivery order resulting from this solicitation to the responsible offeror whose quote conforming to the solicitation meets or exceeds the requirement at the lowest price, Lowest Price Technically Acceptable (LPTA).

The quotes will be evaluated on the basis of the evaluation factors listed below. The technical acceptability will be evaluated on an "acceptable" or "unacceptable" basis. Only those contractors determined to be technically acceptable will be evaluated on price. The following areas will be evaluated:

1. Technical Acceptability (acceptable/unacceptable)
2. Price

Factor 1: Technical Acceptability – The contractor shall provide a written statement addressing each of the following items. The written statement must describe each point and must provide enough detail to determine minimum qualifications.

a. Description of Specifications: Provide a listing of specification meeting the specifications contained in the Schedule.

Factor 2: Price – Contractor shall complete B.3 Price/Cost Schedule. The schedule may be altered, or an alternate schedule used where appropriate in order to express quote detail.

If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
