STATEMENT OF WORK

Supply of Temporary Storage Containers
to the Richmond VAMC
22 Aug 2018

1.0 Description of Services

The Department of Veterans Affairs Richmond VA Medical Center has a requirement for Temporary Storage Containers. The Contractor shall provide a contractor-owned Storage Containers in various sizes on an as needed basis.

1.1 **Definitions and Acronyms**

- a) Contracting Officer (CO) - The CO shall ensure performance of all necessary actions for effective contracting, ensure compliance with the contract terms, and shall safeguard the interests of the United States in the contractual relationship. The CO shall also assure that the contractor receives impartial, fair, and equitable treatment under this contract. The CO is ultimately responsible for the final determination of the adequacy of the contractor's performance.
- b) Contracting Officer's Representative (COR) - The COR is responsible for technical administration of the contract and shall assure proper Government surveillance of the contractor's performance. The COR shall keep a quality assurance file. At the conclusion of the contract or when requested by the CO, the COR shall provide documentation to the CO. The COR is not empowered to make any contractual commitments or to authorize any contractual changes on the Government's behalf. The contractor shall refer any changes they deem may affect contract price, terms, or conditions to the CO for action. shall be appointed via separate letter for this contract. The COR shall be responsible for the effective oversight of this contract to ensure satisfactory contractor performance and protect the public trust. A copy of the COR Appointment letter shall be provided to the Contractor after contract award and shall contain detailed information in regard to the COR and their associated duties, responsibilities and authorities.
- c) Contractor Owned Equipment/Contractor-Acquired Property - means property acquired, fabricated, or otherwise provided by the contractor for performing a contract.
- d) Contractor Performance Assessment Reporting System (CPARS) - CPARS is a web-enabled application that collects and manages the library of automated Contractor Performance Assessment Reports (CPARs). A CPAR assesses a contractor's performance and provides a record, both positive and negative, on a given contractor during a specific period of time. Each assessment is based on objective facts and supported by program and contract management data, such as cost performance reports, customer comments, quality reviews, technical interchange meetings, financial solvency assessments, construction/production management reviews, contractor operations reviews, functional performance evaluations, and earned contract incentives
- e) Equipment - means a tangible item that is functionally complete for its intended purpose, durable, nonexpendable, and needed for the performance of a contract. Equipment is not intended for sale,

and does not ordinarily lose its identity or become a component part of another article when put into use. Equipment does not include material, real property, special test equipment or special tooling.

- f) Government-furnished property (GFP) - means property in the possession of, or directly acquired by, the Government and subsequently furnished to the contractor for performance of a contract. Government-furnished property includes, but is not limited to, spares and property furnished for repair, maintenance, overhaul, or modification. Government-furnished property also includes contractor-acquired property if the contractor-acquired property is a deliverable under a cost contract when accepted by the Government for continued use under the contract.
- g) Government Property - Means all property owned or leased by the Government. Government property includes both Government-furnished property and contractor-acquired property. Government property includes material, equipment, special tooling, special test equipment, and real property. Government property does not include intellectual property and software.
- h) Indefinite Quantity Contract - An indefinite-quantity contract provides for an indefinite quantity, within stated limits, of supplies or services during a fixed period. The Government places orders for individual requirements. Quantity limits may be stated as number of units or as dollar values.
- i) Loss of Government Property - means unintended, unforeseen or accidental loss, damage, or destruction of Government property that reduces the Government's expected economic benefits of the property. Loss of Government property does not include occurrences such as purposeful destructive testing, obsolescence, normal wear and tear, or manufacturing defects. Loss of Government property includes, but is not limited to—
 - (a). Items that cannot be found after a reasonable search;
 - (b). Theft:
 - (c). Damage resulting in unexpected harm to property requiring repair to restore the item to usable condition; or
 - (d). Destruction resulting from incidents that render the item useless for its intended purpose or beyond economical repair.
- j) "Task-Order Contract" means a contract for services that does not procure or specify a firm quantity of services (other than a minimum or maximum quantity) and that provides for the issuance of orders for the performance of tasks during the period of the contract.
- k) Task Order (TO) - An individual requirement for services issued against an existing contract.

2.0 Scope of Requirement

The Contractor shall be responsible for the delivery of Temporary Storage Containers as needed in various sizes to the Richmond VAMC. At a minimum, the contractor shall be responsible for providing all (to include, but not limited to) project management, labor, equipment, materials, hardware, software, special tooling, transportation, loading and unloading ensure the successful performance of all requirements contained within this Statement of Work.

3.0 Description of Work

Contractor to furnish mobile storage units that are weatherproof and water tight in proper working condition. The contractor is to be able to provide multiple sizes of storage containers as requested by the RICVAMC. The contractor will provide delivery and set-up in designated agreed upon location by Contracting Officer Representative (COR) at RICVAMC within 2 business days from the initial request from RICVAMC. All personnel are to be safety trained by our safety unit.

3.1 Temporary Storage Containers

3.1.1 The contractor shall be responsible for providing:

- a) Timely delivery of containers
- b) Containers in various sizes as identified in Attachment I – Price Schedule.
- c) Containers that are weatherproof and water tight in proper working condition.
- d) Periodic/semi-annual inspections of containers to ensure that containers are serviceable

3.2 Delivery Coordination.

- 3.2.1 The Contractor and the COR shall work together on establishing delivery dates and times.
- 3.2.2 The contractor shall be responsible for all aspects of delivery to include but not limited to transporting, downloading, placing, moving and removal of all containers under this contract. Delivery of shall not exceed two weeks from time of coordination by the COR.
- 3.2.3 The contractor shall send an email confirmation for each order within 24 hours from time of request or next business day.
- 3.2.4 The confirmation email will include a tentative delivery schedule and any special instructions needed for delivery/unload coordination.

3.3 Removal

- 3.3.1 The contractor shall be responsible for the removal of any identified containers within 2 weeks of request by the COR.
- 3.3.2 The vendor will send an email confirmation for each order within 24 business hours from time of request. The confirmation email will include a tentative delivery schedule and any special instructions needed for delivery/unload coordination.

3.4 Transition

To permit orderly transition from one contractor to another or in the event that the government elects to replace contractor owned equipment with government owned equipment, or at the end of performance of this contract, the incumbent contractor shall continue to honor the contract's monthly equipment rental fee for a maximum of ninety days beyond the scheduled expiration of the contract period, unless transition from one contractor to another is completed prior to the ninety-day transition period. For any partial month, the contractor will prorate the monthly equipment rental fee accordingly and will continue to maintain its equipment during this transition period.

4.0 Reporting Requirements

- 4.1 Contractor shall be required to submit monthly reports to the COR via email no later than the time of invoice submission as a contract level monthly deliverable. Failure to submit a complete and accurate report may result in invoice rejection until this deliverable has been received by the COR. This may be submitted as a single report if it contains all required information. At a minimum, Monthly Reports, Quarterly and annual Reports shall include, but not limited to, the following:
 - a) Part/Serial Numbers of Containers in Governments possession being invoiced for the period on a CLIN level basis.
 - b) Duration of each container in the Governments possession
 - c) Inspection Reports signed off by COR or Alt COR
 - d) Any billing/invoice issues

- e) Declining Balance on Delivery/Task Order Level
- f) Invoice Log on Delivery/Task Order Level.
- g) Projected Funding Concerns (i.e. Actual Burn vs. Delivery/Task Order Funding Level vs. remaining Period of Performance). If this situation presents, the Contractor shall provide a projection based on actual rate the anticipated exhaustion of funding on the applicable Delivery/Task Order.

No legal liability on the part of the Government for any payment may arise for performance under this contract beyond , until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.

(8) PSC 9610, Ores;

(9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. (c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if the joint venture complies with the requirements in 13 CFR 125.15, provided that any reference therein to SDVO SBC is to be construed to apply to a VA verified SDVOSB as appropriate.

(e) Any service-disabled veteran-owned small business concern (non-manufacturer) must meet the requirements in FAR 19.102(f) of the Federal Acquisition Regulation to receive a benefit under this program.

(End of Clause)

E.7 VAAR 852.273-70 LATE OFFERS (JAN 2003)

This provision replaces paragraph (f) of FAR provision 52.212-1. Offers or modifications of offers received after the time set forth in a request for quotations or request for proposals may be considered, at the discretion of the contracting officer, if determined to be in the best interest of the Government. Late bids submitted in response to an invitation for bid (IFB) will not be considered.

E.8 VAAR 852.273-74 AWARD WITHOUT EXCHANGES (JAN 2003)

The Government intends to evaluate proposals and award a contract without exchanges with offerors. Therefore, each initial offer should contain the offeror's best terms from a cost or price and technical standpoint. However, the Government reserves the right to conduct exchanges if later determined by the contracting officer to be necessary.
