2. **Brief Description of Supplies/ Services required and the intended use/Estimated Amount:**

The proposed contract is for the procurement of the following items:

These items are needed for the Memphis VAMC ambulatory care clinics patient examination rooms. The performance period for this acquisition requires delivery of the exam tables no later than 30 days from date of contract award.

3. **Unique characteristics that limit availability to only one source, with the reason no other supplies or services can be used:**

In accordance with FAR 6.302-1 Only one responsible source and no other supplies or services will satisfy agency requirements. Midmark is the manufacturer of the exam tables. It is essential to the Government to use this peculiar manufacturer. The Memphis VAMC ambulatory care clinics are currently using this peculiar manufacturer exam tables. In support of consistency within the clinics, it is beneficial that the clinical staff continue to use the same product. Thereby precluding consideration of a product manufactured by another company.

4. **Description of market research conducted and results or statement why it was not conducted:**

Market research revealed that Midmark has SDVOSB authorized distributors. Previous solicitations issued for these items revealed SDVOSB can provide pricing.
