Statement of Work

Title of Project: Dental Laboratory Support for VA Central Dental Lab Dallas Texas.

Background: Central Dental Laboratory (CDL) is the only Dental Laboratory in the VA. Dental Clinics throughout the nation send denture prosthetics to this lab. The Central Dental Lab produces Removable partial dentures (RPD) made of casted alloys using the lost-wax technique. Central Dental Lab has a need for a grinding and polishing system that will allow the lab technicians, to process multiple frameworks at the same time, reducing man hours and allowing the prosthesis to be delivered to the Veteran without delay.

Scope of Work:

This request is for a system capable of automatic grinding and polishing of high- precision metal components. The system should be a dry electropolishing system which uses no liquid as the electrolyte, and is suitable for steel, stainless steel, aluminum and titanium components.

Grinding and polishing prosthetics can be highly time consuming, extremely cost-intensive and may render sub-optimal results failing to meet functional requirements. Grinding and polishing of metal parts is an important process step for removing the asperities and defects inherent in components following the initial build process. The removal of peaks, roughness, burs and micro-defects can dramatically improve the corrosion/oxidation resistance, lifespan and friction of a part.

Grinding and Polishing: Should be 1 step completely automated. Polishing without disassembling parts. The requested system should use Non-Conductive Materials – Which allow the frameworks to be processed with the resin bonded to the skeletal, allowing the framework to maintain their original properties. This system should be capable to reach part of the framework regardless of complexity of design. Finishes and polishes the framework maintain the design without rounding edges. No environmentally harmful material discharged during polishing process.

Capacity: This system should have the capacity of grinding and polishing multiple (6-9 pieces at one time), this providing a time savings as the process is to be carried out using the same machine, reducing the wait and preparations time.

(1) Means a small business concern—
