## B.4 SALIENT CHARACTERISTICS

- Must be able to handle injections of unlimited substrates and unlimited inhibitors.
- Must be delivered with mounted O2k chambers.
- Must be pre-calibrated with sensor-specific memory and direct input into DatLab 7 software to maintain research continuity.
- Titration must be compatible with microsyringes (10 mm<sup>3</sup>) for micro sample insertion.
- Must maintain core relative humidity and core relative temperature to maintain the quality control of experiments.
- Must have great sensitivity and limit oxygen flux to  $\pm 1 \text{ pmol s}^{-1}\text{ml}^{-1}$  over the entire experimental oxygen range.
- Oxygen levels must be measured accurately and maintained at a steady state.
- Must be able to perform routine analysis of oxidative phosphorylation in oxidative stress, ischemia-reperfusion, aging, degenerative and inherited diseases, apoptosis, cancer research and drug testing.

- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.
