CONTRACTOR RESPONSIBILITY

1. The contractor shall provide all personal protective equipment (PPE), parts, labor, and other items necessary to complete preventative maintenance on the required equipment. The government shall not provide *Government Furnished Property*. Scheduling shall be the responsibility of the Contractor with the designated Contracting Officer Representative (COR) with a minimum of three (3) days' notice to ensure access to the required working areas.
2. Preventative maintenance shall be in accordance with all Original Equipment Manufacturers' (OEM) specification and instructions. All parts being replaced shall be new, OEM parts or OEM certified replacement parts. The government shall not accept anything other than specified above. If parts that are not certified for use by the OEM are installed and a failure in the equipment occurs, the government shall recoup cost associated with repairs and/or replacement equipment from the contractor. Equipment shall receive a preventative maintenance visit every 6 months, regardless of OEM specification.
3. Preventative Maintenance shall be performed during normal working hours, 7:00AM to 4:30PM, excluding weekends and federal holidays. Overtime shall not be authorized unless explicitly stated in writing by the Contracting Officer.
4. Upon completing the preventative maintenance and inspection, the contractor shall affix an inspection sticker on the equipment in accordance with VA Standard Operating Procedures (SOP).
5. The contractor shall document all repairs made in accordance with VA Policy and provide the documentation to the COR. If the COR is not readily available upon departure the contractor shall provide documentation via electronic means to the COR and the Contracting Officer.

C.2 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 15 days of contract expiration.

(b) Eligible service-disabled veteran-owned offerors will receive full credit, and offerors qualifying as veteran-owned small businesses will receive partial credit for the Service-Disabled Veteran-Owned and Veteran-owned Small Business Status evaluation factor. Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—
