4. Scope

Contractor will provide an 8-yd., front load dumpster for daily refuse generated from daily activities at OWRNC. The 8-yd. container will be placed at a location, determined by the COR, and the contractor will empty container once a week.

Contractor will provide a 20 yd., low-side, roll-off dumpster for granite headstone and concrete debris. 20-yd. container will be permanently placed at OWRNC, at a location determined by the COR. The container will be emptied upon request of the COR, and a new container will be placed upon removal. The 20-yd. roll-off dumpster will be filled to designated fill line. Due to nature of debris the weight will not exceed 20 tons.

Contractor will provide a 20-yd roll-off dumpster for wreaths and general debris. 20-yd dumpster will be delivered upon request of the COR. The 20-yd roll-off dumpster will be placed at a location, determined by the COR. The container will be emptied upon request of the COR. The 20-yd. roll-off dumpster will be filled to designated fill line. The weight cannot be determined due to contents of the dumpster.

7. Period of Performance

The contractor is responsible for conducting business, between the hours of 8:00am and 4:30pm, Monday through Friday, except Federal holidays or when the Government facility is closed due to local or national emergencies, administrative closings, or similar Government directed facility closings.
