Section 1: General Information

1.1 General: This is a non-personal services contract to perform an evaluation of the power distribution system at the VA Central California Health Care System (VACCHCS). The Government shall not exercise any supervision or control over the contract service providers performing the services herein. Such contract service providers shall be accountable solely to the Contractor who, in turn is responsible to the Government.

Section 3: Government Furnished Property, Equipment, and Services

The VA will allow Contractor employees to use the bathroom facilities at the Medical Center. The Contractor is expected to perform reasonable care when using the bathroom facilities. If the Contractor fails to exercise reasonable care when using the bathroom facilities, the VA reserves the right to disallow the use of the bathroom facilities.

Section 4: Contractor Furnished Items and Services

The Contractor will be responsible for the provision of all test equipment, personal protection equipment (PPE), area / equipment protection materials, transportation, per diem, lodging, labor, temporary lighting, temporary wiring and, if required, temporary sources of power (generators) for test equipment.

Section 5: Specific Tasks

5.1 Contractor shall evaluate the electrical distribution system of Building 22A

5.2 All work shall comply with the requirements of ANSI/NETA MTS; STANDARD FOR MAINTENANCE TESTING SPECIFICATIONS for Electrical Power Equipment and Systems, 2015; NFPA 70, National Electrical Code, 2017.

5.3 The primary purpose of this evaluation is to determine if the simultaneous catastrophic failure of numerous electrical assemblies associated with three 600T water chillers was caused by equipment failure within the B22A electrical distribution gear.

5.4 Evaluation shall encompass all electrical systems within Building 22A starting from the medium voltage (12.47 KV) switch and continuing through to the mains of each piece of equipment connected to the Building 22A electrical distribution equipment. This includes, but is not limited to, all breakers, wiring, busbars, meters, switches, surge suppressors, transformers, automatic transfer switches, indicators, contactors, current relays, automatic transfer switches and related items. Each item is to be tested using the appropriate ANSI/NETA procedure. The evaluation will also include a Protective Device Coordination Study.

5.5 Contractor may recommend additional testing if such testing may be beneficial in the isolation of distribution system anomalies which may have caused the equipment failure indicated in Section 5.1.

5.6 This contract is primarily for inspection services. In the event that minor repair or replacement parts are needed, the vendor will provide a written quote to the Government. After review of the quote, the Government will determine if the repairs will be performed under this contract or under a new procurement.

5.7 Contractor shall provide test results in accordance with ANSI/NETA MTS STANDARD FOR MAINTENANCE TESTING SPECIFICATIONS for Electrical Power Equipment and Systems, 2015, Section 5.4, Test Report.

5.8 Contractor shall provide two copies of test data; one set shall be printed (hard copy) and placed in a binder(s). The hard copy shall be mailed to the location listed in section 1.3 to the attention of Gerald Lucas, Engineering Service. Binders shall be labeled on the front cover and spine. Binders shall not exceed two inches in thickness. The second copy of test data shall be in PDF/E format. PDF documents shall be submitted on an appropriately sized, labeled and write protected CD or DVD.

5.9 Upon completion of contract, deliver work complete and undamaged. Existing work (walls, ceilings, partitions, floors, mechanical and electrical work, lawns, paving, roads, walks, etc.) disturbed or removed as a result of performing required new work, shall be patched, repaired, reinstalled, or replaced with new work, and refinished and left in as good condition as existed before commencing work.

5.10 No photography of VA premises is allowed without written permission of the Contracting Officer.

5.11 VA reserves the right to close down or shut down the project site and order General Contractor's employees off the premises in the event of a national emergency. The General Contractor may return to the site only with the written approval of the Contracting Officer.

5.12 Contractor shall confine all operations (including storage of materials) on Government premises to areas authorized or approved by the Contracting Officer.

5.13 Contractor employees are subject to rules of Medical Center applicable to their conduct.

5.14 Execute work so as to interfere as little as possible with normal functioning of the Medical Center as a whole, including operations of utility services, fire protection systems and any existing equipment, and with work being done by others. Do not store materials and equipment in other than assigned areas.
