1. What is the normal operation of the chillers (work altogether or some are standby, etc.)? If they not working altogether, it is possible to turn off the MCC's, one by one, to do test work?

All three chillers are currently off line pending repair. There are some pieces of equipment still dependent on the power distribution equipment included in this work however they can be temporarily powered from other sources. Shutting down the MCC's one by one is possible.

2. Information needed:

For Distribution Switchboard Section:

- Type of breakers; The attachment labeled 262921 Enclosed Switches and Circuit Breakers Commissioning Records provides breaker types for the distribution switch boards, MCC-E1, MCC-6 and MCC-7
- Type of Meter. The meter on the transformer is a Qualitrol 118 ITM. There is a display on the ATS which provides limited metering information. There are no other meters that I am aware of.

For MCC-E1, MCC-6 and MCC-7:

- Type of breakers (main and feeders)

For 12.7kV lines:

- How they been protected; I assume this question is asking if the 12 KV have a TVSS. To my knowledge they do not.
- Single line diagram. The attachment As Built Drawings-Building 22A9 contains a one line diagram for the 12kV system

For ATS: The attachment 263623 Automatic Transfer Switch Startup provides this information.
