



- ◆ Assume the Government has no prior knowledge of you or your experience.
- ◆ NOTE: SF 1442 Block 13(d) – 220 days
- ◆ Submissions – by Group (pages 9-10)
- ◆ Page size and format (page 12)
- ◆ Joint Ventures (page 12)

# Submission Requirements Instructions to Offerors Cont'd

- ◆ Representations and Certifications(section 00300) including requirement to register in SAM.gov
- ◆ SDVOSB – VIP ([www.vip.vetbiz.va.gov](http://www.vip.vetbiz.va.gov))
- ◆ Submission Deadline
  - E-mail and physical hard copies (page 10-11)
- ◆ E-mail File Size
- ◆ Points of Contact

# 00110 Evaluation of Offerors (page 30)

- ◆ Proposal Evaluation - Two-phase evaluation
  - Phase I – Current
  - Phase II – Seed project (TBD)
- ◆ Discussions not intended
- ◆ Anticipated awards (we reserve the right to award more or less):
  - Group 1 – 10 awards
  - Group 2 – 10 awards

# 00110 Evaluation of Offerors (continued)

- ◆ Evaluation Factors:
  - Factor 1 - Safety
  - Factor 2 - Recent, Relevant Experience of the firm
  - Factor 3 - Past Performance
  - Factor 4 – Seed Project (Phase II)
- ◆ Basis of Award – tradeoff
  - Factors 1 and 2 and equal
  - Factors 1 and 2 when combined are equal to Factor 3
  - Factors 1, 2 and 3 when combined are equal to Factor 4

# 00100 Evaluation of Offerors (continued)

- ◆ TIP: Tailor your answers to the Basis of Evaluation sections.
- ◆ Factor 1 – Safety
  - EMR with any explanations (if needed)
  - Certification – a written self-certification is sufficient
  - Technical approach to safety

# 00100 Evaluation of Offerors (continued)

- ◆ Factor 2 – Experience
  - Offeror must be prime
  - Group 1 projects > \$25K
  - Group 2 projects > \$800K
  - Complete Attachment A
  - Follow TIP from Slide 15

# 00100 Evaluation of Offerors (continued)

- ◆ Factor 3 – Past Performance
  - Have references from Factor 2 complete Attachment B, and the references should submit the Attachment back to the Government. Do not submit the Attachment B with your Proposal.
  - Submit CPARs reports for projects identified in Factor 2 (if applicable)
  - Adverse Information
  - Organizational Structure Change
