## B.3 PERFORMANCE WORK STATEMENT

### PERFORMANCE WORK STATEMENT

#### TRAINING SIMULATION CAPS5

##### 1. BACKGROUND

The Clinician Administered PTSD Scale (CAPS) is the “gold standard” for posttraumatic stress disorder (PTSD) assessment and diagnosis for both military Veteran and civilian trauma survivors. The CAPS is a structured interview in which a clinician asks a patient a series of questions to identify the presence of PTSD symptoms. A quality interview takes approximately 60 minutes to administer. The CAPS was recently revised to reflect the PTSD diagnostic criteria changes in the *Diagnostic and Statistical Manual-5th* edition (*DSM-5*). This revised version is called the CAPS-5.

##### 2. SCOPE

As further explained below, this contract calls for the Contractor to design and maintain web-based CAPS-5 training/simulation for VA clinician use. This Performance Work Statement (PWS) calls for an advanced training simulation that uses artificial intelligence, real-time and summary feedback, and interactive virtual patient technology to allow learners to practice the administration and scoring of the Clinician Administered PTSD Scale for DSM-5 (CAPS-5). The scope of work includes all management, supervision, labor, materials, supplies, equipment, certification, licenses, or other resources necessary to execute the contract.

The scope includes:

- System Development and Coding of the training simulation
- Content development for the training simulation
- Deployment of the web-based training simulation.
- Hosting of the training simulation to be provided by the contractor under this contract beginning in the base period and continuing to contract termination. (This service may be acquired by the contractor from a third-party provider)
- Analytics
- Maintenance of and updates to training simulation during option years

### **3. OBJECTIVES**

#### **3.1.OBJECTIVE 1**

Develop, deploy, and support the management of a SCORM- and §508-compliant web-based CAPS-5 training course. The course will be completed in the base year of the contract.

#### **3.2.OBJECTIVE 2**

Develop, deploy, and support management of a NCPTSD approved CAPS-5 training course that makes use of advanced artificial intelligence technology, creating an immersive experience for the learner.

#### **3.3.OBJECTIVE 3**

Develop, deploy, and support management of a course that provides summary feedback on the learner's performance in administering the NCPTSD approved CAPS-5 training course.

#### **3.4.OBJECTIVE 4**

Design a formal program analytics plan that provides a systematic method for collecting, analyzing, and using data to answer questions about how the course is working.

### **4.0 GENERAL TASKS**

This PWS aims to achieve one (1) primary high-level result:

This contract calls for the Contractor to design and maintain a web-based CAPS-5 training/simulation for VA clinician use. The course shall provide advanced training simulation that uses artificial intelligence, real-time and summary feedback, and interactive virtual patient technology to allow learners to practice the administration and scoring of the Clinician Administered PTSD Scale for *DSM-5* (CAPS-5) [Past Month Version]. It will include summary feedback and an overall rating of the learner's skill in

the administration and scoring of the CAPS-5. It will also describe specific domains, if any, in which the learner needs additional practice to gain proficiency in CAPS-5 administration.

Within one year of the date of award, the vendor will deploy the developed simulation and perform ongoing maintenance and hosting of the training simulation. The training must be §508- and SCORM-compliant and accessible to learners from behind the VA firewall.

## **5.0 SPECIFIC TASKS AND DELIVERABLES**

Description of Tasks and Associated Deliverables: The vendor shall provide the specific deliverables described below within the performance period stated in this PWS.

### **5.1 THE CONTRACTOR SHALL DESIGN AND BUILD A WEB-BASED TRAINING SIMULATION FOR CLINICIANS ADMINISTERING THE CAPS-5.**

#### **5.1.1 Minimum Requirements:**

- Program a Structured Interview with Unscripted Elements: The CAPS-5 is a structured interview in which a clinician asks a patient a series of questions to identify the presence of PTSD symptoms. The interviewer must administer the CAPS-5 as written, word-for-word, like a script. This training will instruct users in the proper administration of the CAPS-5. Despite the structured nature of the CAPS-5, a quality interview will generally require that the interviewer deviate from the proscribed language. Through its use of interactive virtual patient technology, the training will give learners skill particularly in those instances where it is appropriate to deviate from the script. The contractor will have to program the course to allow for the following deviations:
  - by including the interviewee's own words to ask probing questions;
  - by acknowledging information previously provided by the interviewee; and
  - by asking the interviewee for more information.

The learner must be able to pose both scripted and unscripted questions as well as statements not posed in the form of a question. The learner must be able to pose questions that deviate from the script in their own words through spoken or typed text. Simply choosing from a menu of possible questions and statements to pose, even if they are posed verbally, is not adequate for the purposes of this

training. As noted above, the learner must be able to craft their own series of questions when probing for additional information.

The virtual patient must have the capacity to respond appropriately to questions and statements that are somewhat off target. With the help of the on-screen coach's ongoing feedback, the learner will have the opportunity to correct and refine their administration of the measure throughout the course. This training will use advanced artificial intelligence technology, creating an immersive experience for the learner.

- **Software Requirements:** The contractor shall develop software requirements and architecture in accordance with the contractor's software development process plan. The contractor shall use modeling and simulation as appropriate for architecture validation. The contractor shall determine if existing open source software products are capable of meeting any capabilities, perform a detailed software reuse evaluation, and document the results of the analysis.
- **Course Management and Maintenance:** The contractor will manage and maintain the training simulation throughout the system lifecycle.
- **Seat Time:** The training is expected to last approximately 120-140 minutes depending on the learner's prior familiarity with the administration of the CAPS-5.
- **Look and Feel of Virtual Patient:** The contractor must use artificial intelligence, natural language processing, interactive virtual patient technology to create a virtual patient that looks, speaks, and behaves like a real person (as might be seen in a high-quality video game) and interacts dynamically with the learner. Response of the virtual patient should be fast (mimicking that of a typical human conversation).
- **Verbal Responses:** The virtual patient's verbal responses must be available via audio and with captioning.
- **On Screen Depiction of the CAPS-5 Instrument:** This training will feature an on-screen depiction of the CAPS-5 measure that will have learner's rate symptom presence, intensity, frequency, and severity while administering the measure to a virtual patient.

- **Coaching:** The course must integrate ongoing real-time feedback and coaching throughout the administration and scoring of the CAPS-5 in the form of an on-screen coach who advises, guides, and corrects the learner as necessary through recorded prompts. Captioning---either closed or open---must be available to show the coach's feedback. Coaching will focus on aspects of CAPS-5 administration that are known to cause challenges for novice administrators.
- **Learner Summary:** At the conclusion of the training, the learner will receive summary feedback and an overall rating on their performance administering and scoring the CAPS-5. The summary should describe specific domains, if any, in which the learner needs additional practice as identified by the coach during delivery to gain proficiency in CAPS-5 administration.
- **User Interface (UI):** The contractor will design and build a prototype of the UI which will focus on maximizing usability and the user experience. The design must balance the technical functionality with the visual elements.
- **SCORM compliance:** Using SCORM standards, the course will track learners' progress and allow learners to return to the course where they left off, thus enabling learners to complete the training over the course of more than one sitting.

## **5.2 THE CONTRACTOR SHALL PROVIDE HOSTING OF THE WEB-BASED CAPS-5 TRAINING COURSE.**

- General analytics should include data on program use such as number of visitors on the site, number of visits to the site by unique users, time spent on site, percent course completion, device used, operating system, etc.
- The more detailed analytics should help NCPTSD and the contractor understand how well the course is working so that corrections can be made to content or functioning of the course. For example: Are there any questions where users are unable to get the right answer or where it is taking longer to get to the right answer than expected? Are there places where the interactive virtual patient gets stuck in a loop? Are there coach suggestions that fail to result in corrective learner actions, and so on.

The contractor shall provide skilled, experienced professional and/or technical personnel for successful contractor accomplishment of the work to be performed under this contract. Personnel performing duties as the Project Manager and personnel performing as the technical development and content development leads are defined as key personnel and are those persons whose resumes were submitted with the quote. The PWS does not necessitate separate personnel for each of these areas of responsibility. The vendor will notify the COR when substitutions will be made to these personnel and provide a detailed explanation of the circumstances necessitating the substitution. The vendor shall submit a complete resume for the proposed substitute / replacement.

## **8. REPORTING REQUIREMENTS**

The vendor shall provide the COR with monthly progress reports submitted electronically via email in MS Word. See Task 4.3.1.3. The reports are due to the COR by the second workday following the end of each calendar month throughout the project's duration, including both the base and option periods. The final report is due to the COR by the end of the period of performance.

The progress report will address all work completed during the preceding month and will present the work to be accomplished during the subsequent month. This report will also identify any problems that arose and a statement explaining how the problem was resolved. This report will also identify any problems that have arisen but have not been completely resolved with an explanation.

Vendor shall complete each deliverable according to the approved schedule. If for any reason the scheduled time for a deliverable cannot be met, the vendor is required to explain why (include the original deliverable due date) in writing to the CO, including a firm commitment of when the work shall be completed. This notice to the CO shall cite the reasons for the delay and the impact on the overall project. The CO will then review the facts and issue a response in accordance with applicable regulations.

The VA COR is responsible for coordinating Government review.

## SECTION C - CONTRACT CLAUSES

### C.1 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (JAN 2017)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

(1) Within a reasonable time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics,

quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title.* Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty*. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability*. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances*. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts*. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence*. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

(1) The schedule of supplies/services.

(2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;

(3) The clause at 52.212-5.

(4) Addenda to this solicitation or contract, including any license agreements for computer software.

(5) Solicitation provisions if this is a solicitation.

(6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments

(9) The specification.

(t) *System for Award Management (SAM)*.

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the



SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

*(u) Unauthorized Obligations.*

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an “I agree” click box or other comparable mechanism (e.g., “click-wrap” or “browse-wrap” agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) *Incorporation by reference.* The Contractor’s representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

(1) The Comptroller General of the United States, or an authorized representative of the Comptroller General, shall have access to and right to examine any of the Contractor's directly pertinent records involving transactions related to this contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.

(3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.

## SECTION E - SOLICITATION PROVISIONS

(d) If the Offeror does not become registered in the SAM database in the time prescribed by the Contracting Officer, the Contracting Officer will proceed to award to the next otherwise successful registered Offeror.

(e) Processing time, which normally takes 48 hours, should be taken into consideration when registering. Offerors who are not registered should consider applying for registration immediately upon receipt of this solicitation.

(2) Has a felony criminal violation under any Federal or State law within the preceding 24 months, unless the agency has considered suspension or debarment of the corporation and Suspension and Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(b) The Offeror represents that—

### **E.3 52.209-7 INFORMATION REGARDING RESPONSIBILITY MATTERS (JUL 2013)**

(a) *Definitions.* As used in this provision—

"Administrative proceeding" means a non-judicial process that is adjudicatory in nature in order to make a determination of fault or liability (e.g., Securities and Exchange Commission Administrative Proceedings, Civilian Board of Contract Appeals Proceedings, and Armed Services Board of Contract Appeals Proceedings). This includes administrative proceedings at the Federal and State level but only in connection with performance of a Federal contract or grant. It does not include agency actions such as contract audits, site visits, corrective plans, or inspection of deliverables.

"Principal" means an officer, director, owner, partner, or a person having primary management or supervisory responsibilities within a business entity (e.g., general manager; plant manager; head of a division or business segment; and similar positions).

(b) The offeror [ ] has [ ] does not have current active Federal contracts and grants with total value greater than \$10,000,000.

(c) If the offeror checked "has" in paragraph (b) of this provision, the offeror represents, by submission of this offer, that the information it has entered in the Federal Awardee Performance and Integrity Information System (FAPIS) is current, accurate, and complete as of the date of submission of this offer with regard to the following information:

(1) Whether the offeror, and/or any of its principals, has or has not, within the last five years, in connection with the award to or performance by the offeror of a Federal contract or grant, been the subject of a proceeding, at the Federal or State level that resulted in any of the following dispositions:

(i) In a criminal proceeding, a conviction.

(ii) In a civil proceeding, a finding of fault and liability that results in the payment of a monetary fine, penalty, reimbursement, restitution, or damages of \$5,000 or more.

(iii) In an administrative proceeding, a finding of fault and liability that results in—

(A) The payment of a monetary fine or penalty of \$5,000 or more; or

(B) The payment of a reimbursement, restitution, or damages in excess of \$100,000.

(iv) In a criminal, civil, or administrative proceeding, a disposition of the matter by consent or compromise with an acknowledgment of fault by the Contractor if the proceeding could have led to any of the outcomes specified in paragraphs (c)(1)(i), (c)(1)(ii), or (c)(1)(iii) of this provision.

(2) If the offeror has been involved in the last five years in any of the occurrences listed in (c)(1) of this provision, whether the offeror has provided the requested information with regard to each occurrence.

(d) The offeror shall post the information in paragraphs (c)(1)(i) through (c)(1)(iv) of this provision in FAPIS as required through maintaining an active registration in the System for Award Management database via <https://www.acquisition.gov> (see 52.204-7).

#### **E.4 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS (JAN 2017)**

(a) *North American Industry Classification System (NAICS) code and small business size standard.* The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). However, the small business size standard for a concern which submits an offer in its own name, but which proposes to furnish an item which it did not itself manufacture, is 500 employees.

(b) *Submission of offers.* Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show—

- (8) A completed copy of the representations and certifications at FAR 52.212-3 (see FAR 52.212-3(b) for those representations and certifications that the offeror shall complete electronically);
- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions, including alternative line items (provided that the alternative line items are consistent with subpart 4.10 of the Federal Acquisition Regulation), or alternative commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers.

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

(C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.

**A. VOLUME I –TECHNICAL APPROACH – No pricing information is to be provided in the Technical Volume.**

The offeror shall submit a Technical Approach not to exceed 30 pages.

The Technical Approach shall address in detail how the offeror proposes to accomplish the government's needs. The proposal shall include evidence of specific methods and techniques for completing each element of the Performance Work Statement and the bulleted items below, the employment of innovative methodologies to provide the type of services needed and the identification of potential risks and mitigations. The Technical Approach shall be written in concise, easily understood language.

The technical approach must include:

- Overview of the company's experience and capability to program custom computer coding in-order-to deliver advanced training simulations utilizing interactive virtual patient technologies and artificial intelligence. Overview should provide concrete evidence of experience and capability vice generalized statements.
- A staffing plan including the labor categories required to perform the PWS. Do not include staffing for positions that do not directly perform the direct project management, technical or content development requirements of the contract. - Explain in detail the intended attributes of the simulation coaching and feedback functions.
- Explain in detail how the vendor will implement formal data analytics requirements.

- Explain in detail the characteristics of the intended training simulation related to “Natural Language Processing” capabilities and processes to allow other than scripted input and output from the human learner or virtual patient as appropriate.
- The offeror shall provide a link to products it created that demonstrates skill with instructional design principles, artificial intelligence, and interactive virtual patient technologies. The product should demonstrate the ability to create a virtual patient that is life-like and realistic (i.e., displays emotions through facial features in a convincing manner, uses body language appropriately, with high end graphics (similar to those in the gaming industry)).
- The offeror will provide a draft Government Quality Assurance Surveillance Plan. (Note this is not how the offeror will implement internal quality control but a recommended plan to implement how the government will monitor the performance requirements of the contract including what the offeror considers effective performance metrics).

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.
