Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** This is a retrofill that will not require the breaker case to be changed and will result in savings to the VA and this product will also match our existing breaker configuration reducing retrofit costs.
- 6. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** Square D uses GSA negotiated pricing for this purchase as shown on the quote. GSA contract number GS-07F-9462G

Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted: See #5 and #6 justifications. This is a direct replacement designed and engineered for this application. Additionally the National Electrical Code states in article 240.86 (B) that the manufacturer of an electrical panel shall label the panel and the label shall show the catalog numbers of those breakers that are suitable for use with that particular piece of equipment. Only Square D catalog numbers are listed on the panels involved with this project.

According to the NRTL, Nationally Recognized Testing Laboratory (NRTL) Program, which is a part of OSHA's Directorate of Technical Support and Emergency Management; if a fuse/circuit breaker series combination is chosen, the designer or contractor has much greater flexibility to mix panelboard/switchboard manufacturers.

For instance, the lighting panel could be from one manufacturer with that manufacturer's circuit breakers installed and the distribution panel equipped with switches can be from another manufacturer. However, if a circuit breaker/circuit breaker series combination is selected, then the lighting panelboard and distribution panelboard must come from the same manufacturer with their circuit breakers installed in both. There are no circuit breaker/circuit breaker series combinations that mix circuit breakers of different manufacturers. This is what we have in this case a circuit breaker / circuit breaker combination.


