2. **Brief Description of Supplies/ Services required and the intended use/Estimated Amount:** This action is for the justification and approval for the procurement of a Karl Storz Brand Name only Otolaryngology/ ENT video system and video cart equipment to support existing flexible and rigid ENT scopes already in use in the facility's operating room. The current video system is leased from Karl Storz with an expiration of November 31, 2018. The action will be awarded as a new action for a one-year lease with four (4) exercisable option years.

3. **Unique characteristics that limit availability to only one source, with the reason no other supplies or services can be used:** The requested 4K ENT Video System/Video Care units are compatible with the Karl Storz TH120 4K Camera Heads and existing Karl Storz digital ENT scopes currently in use for Otolaryngology surgical procedures. It would not be cost effective to purchase more scopes with another brand to fit any other brand of Video towers or cart. The requested equipment will support critical, high volume procedures for the Otolaryngology Service.
4. **Description of market research conducted and results or statement why it was not conducted:** Karl Storz has been a trusted brand for ENT diagnostic and surgical procedures. Most of all the current equipment used in operating room and the ENT clinic is Karl Storz. A market research was done with the manufacture of Karl Storz and a Distributor of Karl Storz Products; L1 Enterprise.
