NCO-17 intends to place a sole source delivery/task order with Beckman Coulter, Inc. for a Urinalysis Cost-Per-Reportable Result (CPRR) agreement/program against their VA National Acquisition Center (NAC) Federal Supply Schedule (FSS). The proposed action will be a new action. The proposed action will have a base period of performance and four (4) option periods. Base period of performance: 10/1/2018 through 9/30/2019.

3. Description of Supplies or Services:

Urinalysis CPRR agreement/program. Program consists of no-cost equipment rental, required reagents and consumable supplies at a CPRR cost of (price to be determined). CPRR program also includes equipment maintenance services and factory-based training. The CPRR program will be administered at three Central Texas Veterans Health Care System (CTVHCS) locations; Olin Teague Veterans Medical Center, Temple, TX; Doris Miller VA Medical Center, Waco, TX; and the Austin Outpatient Clinic, Austin, TX. The urinalysis instruments will be operated by VA laboratory personnel to analyze specimens collected from patients; pertaining to their diagnosis, treatment and prevention of diseases.

Beckman Coulter's Iris/Iricell integrated urinalysis testing analyzer is the only instrument offered by a NAC FSS holder that can perform body fluids testing parameters. The required equipment at the Waco and Austin locations must be compatible with the equipment at the Temple location so that all CTVHCS reference ranges correlate.

The Contracting Officer can also review past urinalysis CPRR program orders to compare the proposed prices with prices reasonable and best values on previous purchases.

(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:

Market research identified that there are three (3) large business NAC FSS vendors in SIN 66 III, category 605-4A, Clinical Urinalysis Analyzers. A review of the analyzers offered by the other two FSS vendors identified that they do not offer instruments that have body fluids testing parameters.

(7) ANY OTHER FACTS SUPPORTING THE JUSTIFICATION:

A special notice, notice of intent to award a sole source procurement, was posted on the Federal Business Opportunities website on 6/28/2018. The notice stated that all responsible sources may submit a capability statement, proposal or quotation, which shall be considered by the agency to determine if a comparable source is available and more advantageous to the government. There have been no responses to the notice.

(8) A STATEMENT OF THE ACTIONS, IF ANY, THE AGENCY MAY TAKE TO REMOVE OR OVERCOME ANY BARRIERS THAT LED TO THE RESTRICTED CONSIDERATION BEFORE ANY SUBSEQUENT ACQUISITION FOR THE SUPPLIES OR SERVICES IS MADE:

Beckman Coulter, Inc. is the only firm capable of providing the requested supplies/services without the Veteran's Health Administration experiencing substantial duplication of cost that could not be expected to be recovered through competition and unacceptable delays in fulfilling its requirements. The CTVHCS pathology & laboratory medicine service will conduct market research prior to the exercise of option renewals and new requirements to determine if there have been any changes to the marketplace.

(9) REQUIREMENTS CERTIFICATION: I certify that the requirement outlined in this justification is a Bona Fide Need of the Department of Veterans Affairs and that the supporting data under my cognizance, which are included in the justification, are accurate and complete to the best of my knowledge. I understand that processing of this limited sources justification restricts consideration of Federal Supply Schedule contractors to fewer than the number required by FAR Subpart 8.4.
