Justification and approval for other than full and open competition for a new firm fixed price contract to be awarded for a Mediastinoscopy Working System from Storz. This part of the remaining equipment to be purchased will enable surgeons to use both hands while operating, as it is a pneumatic holding arm for the descending mediastinoscope which can open to a duckbill, giving greater working area in the chest area especially for irrigation and suction.

The Surgical Services Department has already purchased the equipment on contract to compliment this equipment order. No other company is utilized for Mediastinoscopies. This is a result of recent action plan from delays in surgery. Need to standardize all equipment per VA Memo dated May 10, 2012 from Deputy under Secretary for Health for Operations Management; subject Sterile Processing Service Needs Assessment.

The OR Table Accessories will enable surgeons to use both hands while operating, as it is a pneumatic holding arm for the descending mediastinoscopies which can open to a duckbill, giving greater working area in the chest area especially for irrigation and suction. The Surgical Services Department has already purchased the equipment on contract to compliment this equipment order. The OR Table Accessories requested must be purchased in FY 2012 so patients can receive steinoscopies in house. At this point sensitive Thoracic procedures are being sent out for fee. Surgical Service is proactively trying to increase case loads to cut costs of services that must be sent out for fee. Additionally the inability to conduct these procedures at the WBVAMC prevents Dr. Sheikh from providing continuous care to his Veteran patients who are in need of this type of Thoracic Care/Procedure.

6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:

Unable to locate any other distributors of the model numbers to integrate with existing system.

7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:

This equipment provides a return on investment with the procedures able to be completed in hospital by thoracic/vascular surgeon.






