## SECTION B - CONTINUATION OF SF 1449 BLOCKS

### B.1 GOVERNING LAW

Federal law and regulations, including the Federal Acquisition Regulations (FAR), shall govern this Contract/Order. Federal law and regulation including, without limitation, the Contract Disputes Act (41 U.S.C. § 7101 *et seq.*), the Anti-Deficiency Act (31 U.S.C. § 1341 *et seq.*), the Competition in Contracting Act (41 U.S.C. § 3301 *et seq.*), the Prompt Payment Act (31 U.S.C. § 3901 *et seq.*), Contracts for Data Processing or Maintenance (38 USC § 5725), and FAR clauses 52.212-4, 52.227-14, 52.227-19 shall supersede, control, and render ineffective any inconsistent, conflicting, or duplicative provision in any commercial license agreement. In the event of conflict between this Clause and any provision in the Contract/Order or the commercial license agreement or elsewhere, the terms of this Clause shall prevail. Claims of patent or copyright infringement brought against the Government as a party shall be defended by the U.S. Department of Justice (DOJ). 28 U.S.C. § 516. At the discretion of DOJ, the Contractor may be allowed reasonable participation in the defense of the litigation. Any additional changes to the Contract/Order must be made by contract/order modification (Standard Form 30) and shall only be effected by a warranted Contracting Officer. Nothing in this Contract/Order or any commercial license agreement shall be construed as a waiver of sovereign immunity.

### **1.0 REQUIREMENTS**

The Department of Veterans Affairs, Office of Information and Technology, Enterprise Program Management Office, VA.GOV Modernization project requires the use of ten (10) digital Veteran images for marketing and artistic purposes as a means to highlight a variety of Veterans from every era and branch of service for the purpose of promoting the services offered by VETS.GOV and VA.GOV websites. The required Licensing support is delineated below.

#### **1.1.COORDINATION OF USE OF IMAGES**

The specific image(s) to be published are listed in section 1.2 below. The Contractor shall contact all selected subjects to obtain permission for inclusion on VETS.GOV and/or VA.GOV and to certify and warrant that the Veteran's full name, highest rank held, branch of service, dates of service and military profession and honorable separation status are correct and current at the time of delivery of the images, including prior to each Option Period, if exercised. In the event that permission is not obtained or contact information cannot be verified for any of the images, another image will be chosen immediately by the VA, for which the Contractor shall certify and warrant the veteran information to replace the image in question. Additionally, if at any point during the Period of Performance (PoP), a Veteran notifies the Contractor and/or VA that they have changed their mind and choose to no longer have their image represented on VETS.GOV and/or VA.GOV, another image will be chosen within fifteen days by VA, after which the Contractor shall certify and warrant the Veteran information to replace the image in question and deliver the certified and warranted replacement image within fifteen days of VA's notice of the selection. Veterans' portraits will not be used by the VA in direct correlation to specific medical conditions that would lead the viewer to infer the veteran suffers from the associating ailment. Veterans' likeness will not be altered with skin-tone lightening (with the exception of contrast and brightness edits or application of a color filter to black-and-white images), scar removal, or facial structure manipulation.

Each image may be used an unlimited number of times for VETS.GOV and VA.GOV within the PoP for the purpose of promoting the services offered by VETS.GOV and VA.GOV websites.

This contract permits all forms of commercial or promotional use, including, without limitation, display on a website as a design element or in branding materials or profile designs on commercial sites or social media websites pertaining to the Department of Veterans Affairs' VETS.GOV and VA.GOV websites.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. ### **E.3 REPRESENTATION OF LIMITED RIGHTS DATA AND RESTRICTED COMPUTER SOFTWARE (DEC 2007)**

(a) This solicitation sets forth the Government's known delivery requirements for data (as defined in the clause at [52.227-14](#), Rights in Data—General). Any resulting contract may also provide the Government the option to order additional data under the Additional Data Requirements clause at [52.227-16](#), if included in the contract. Any data delivered under the resulting contract will be subject to the Rights in Data—General clause at [52.227-14](#) included in this contract. Under the latter clause, a Contractor may withhold from delivery data that qualify as limited rights data or restricted computer software, and deliver form, fit, and function data instead. The latter clause also may be used with its Alternates II and/or III to obtain delivery of limited rights data or restricted computer software, marked with limited rights or restricted rights notices, as appropriate. In addition, use of Alternate V with this latter clause provides the Government the right to inspect such data at the Contractor's facility.



(b) By completing the remainder of this paragraph, the offeror represents that it has reviewed the requirements for the delivery of technical data or computer software and states [*offeror check appropriate block*]

(c) Any identification of limited rights data or restricted computer software in the offeror's response is not determinative of the status of the data should a contract be awarded to the offeror.

#### **E.4 VAAR 852.233-70 PROTEST CONTENT/ALTERNATIVE DISPUTE RESOLUTION (JAN 2008)**

(a) Any protest filed by an interested party shall:

- (1) Include the name, address, fax number, and telephone number of the protester;
- (2) Identify the solicitation and/or contract number;
- (3) Include an original signed by the protester or the protester's representative and at least one copy;
- (4) Set forth a detailed statement of the legal and factual grounds of the protest, including a description of resulting prejudice to the protester, and provide copies of relevant documents;
- (5) Specifically request a ruling of the individual upon whom the protest is served;
- (6) State the form of relief requested; and
- (7) Provide all information establishing the timeliness of the protest.

(b) Failure to comply with the above may result in dismissal of the protest without further consideration.

(c) Bidders/offerors and contracting officers are encouraged to use alternative dispute resolution (ADR) procedures to resolve protests at any stage in the protest process. If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.

As an alternative to filing a protest with the contracting officer, an interested party may file a protest with the Deputy Assistant Secretary for Acquisition and Materiel Management, Acquisition Administration Team, Department of Veterans Affairs, 810 Vermont Avenue, NW., Washington, DC 20420, or for solicitations issued by the Office of Construction and Facilities Management, the Director, Office of Construction and Facilities Management, 810 Vermont Avenue, NW., Washington, DC 20420. The protest will not be considered if the interested party has a protest on the same or similar issues pending with the contracting officer.

A complete Section B.4 Price/Delivery Schedule. All prices shall contain no more than 2 decimal places. For each priced line item ensure the “Unit price” column multiplied by the “Qty” column equals the “Total Price” column.

All offerors are cautioned that any deviation from the Government’s minimum terms and conditions set forth in this Solicitation may result in your offer being deemed by the Government to be non-conforming to the requirements and excluded from consideration for award.
