



2. **Nature and/or Description of the Action Being Processed:** This is a request for other than full and open competition for Stryker Gamma 3 Instrumentation.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** The items needed include basic and disposable instruments as well as implants used for hip nailing procedures.

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (Applicability of Authority):** 41 U.S.C. 253(c)(5) and 38 U.S.C. 8123 as illustrated in VAAR 806.302-5(b)(1) authorize the procurement of orthopedic and prosthetic appliances without providing full and open competition. This instrumentation includes brand name items available from Stryker and have been selected by our orthopedic surgeon at this facility. Our orthopedic surgeon is experienced in using this specific instrumentation for hip nailing procedures.
6. **Description of Efforts Made to Ensure that Offers Are Solicited from as Many Potential Sources as Deemed Practicable:** None.
7. **Determination By the Contracting Officer That the Anticipated Cost to the Government Will Be Fair and Reasonable:** The prices for this instrumentation are comparable to similar instrumentation from another manufacturer.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** Previous market research revealed that this particular instrumentation is not available through any FSS source and is available only in the open market.
