Item No. 1 - BASE BID: Provide all labor, supervision, tools, equipment and materials required to perform Exterior Maintenance involving approximately 922,000 square feet of the exterior space of the Medical Center. Complete pressure washing/spraying of the entire medical center to include - Building 6 and the Research Building that does not face the construction area; Tuck Pointing and sealing all the exterior windows (1000) in the Main Hospital Building floors 1-4; repair all cracks in the exterior of the building; replace any damaged or missing pieces of brick on the building; wash all windows at the completion of the project; tuck point and seal all penetrations in the exterior stairwells to address moisture infiltration in the interior of the building.
