B.7 STATEMENT OF WORK

CHARLES GEORGE VA MEDICAL CENTER (CGVAMC) FACILITY MANAGEMENT SERVICE PORTABLE RADIOS

STATEMENT OF WORK

1.0 General:

Due to the age of Facility Management Service's (FMS) current portable radio suite, the CGVAMC FMS has a need to replace 150 portable radios, multi-unit charging stations, and related equipment.

2.0 SCOPE:

The CGVAMC intends to procure 150 APX 4000 UHFR1 Megahertz Model 2 portable radios, multi-unit charging stations, and related equipment, as required to be procured, programmed, and delivered to the CGVAMC FMS.

3.0 CONTRACT REQUIREMENTS

3.1 The contractor shall provide 150 APX 4000 UHFR1 Megahertz Model 2 portable radios and associated multi-unit charging stations, and related equipment, as required to be procured, programmed and delivered to the CGVAMC FMS.

3.2 The radios must meet the following requirements (Salient Characteristics):

- Must include two(2) knob configuration
- Must include a 3-year service agreement from the product "in-service" date.
- Must include ENH 3600 or 9600 Trunking Baud SIN
- Must have an 8 – 10 hour battery life
- Must be capable to operate in frequency ranges of:

- 700/800 (763-776, 793-806, 806-824, 851-870 MHz)
 - 900 (896-901, 935-940 MHz)
 - VHF (136-174 MHz)
 - UHF R1 (380-470 MHz)
 - UHF R2 (450-520 MHz)
-
- Must operate on Lithium Ion rechargeable batteries
 - Must have backlight keypad

3.2 The Contractor shall verify the radios are programmed to the band(s) and frequencies in use at the time of delivery. The contractor shall also provide technical assistance and “Help Desk” services on a 24 hour, seven (7) days per week basis to assist the CGVAMC FMS trouble shoot problems and manage warranty related issues. Problems shall be tracked by way of ticket numbers when required. Where issues can’t be resolved by the CGVAMC FMS, the contractor shall dispatch a technician within 24 hours to resolve the issue(s) on-site.

3.2.1 In cases where the problems can’t be resolved, the contractor shall provide replacement radios under the manufacturer’s warranty at no cost to the Government.

3.3 The parties agree that the Contractor, its employees, agents, and subcontractors shall not be considered VA employees for any purpose.

4.0 CONTRACT PERFORMANCE MONITORING:

The Contracting Officer's Representative (COR), appointed in writing, will be responsible for monitoring the Contractor's performance and will work with the Contractor with the initial setup, verification, problem resolution, and warranty issues.

4.1 The COR will furnish a statement in writing to the Contracting Officer (CO) at close out of the contract to include a summary of contractor actions and a statement that all requirements of the contract were fulfilled as agreed.

4.2 A summary evaluation of contractor performance, based upon the compliance of contract requirements as evidenced in the monitoring procedures shall be forwarded by the monitoring official to the CO prior to contract closure.

5.0 RESPONSIBILITY FOR LOSS, or PERSONAL INJURY OF CONTRACTOR

PERSONNEL

5.1 The Government will not be responsible or held liable for any loss, damage, personal injury or loss of life of Contractor personnel, not caused by the fault, negligence, wrongful omission of the Government, its agents or its employees, occurring at any time such personnel are in the performance of this contract.

5.2 The Contractor shall be liable and shall indemnify and hold harmless the Government, its agents, and employees, against all actions or claims for damages to persons, property, including death not caused by the fault, negligence, wrongful act, or wrongful omission of the Government, its agents, or employees.

5.3 The Contractor shall be liable and shall indemnify and hold harmless the Government, its agents, and employees against all action or claims for all damages to persons or property, including death arising or resulting from the fault, negligence, wrongful act, or wrongful omission of the Contractor personnel (IAW) the Federal Tort Claim Act, 28 United States Code (USC) §2671- §2680.

6.0 CONTRACT ADMINISTRATION DATA:

6.1 The CO is the only person authorized to approve changes or modify any or all of the requirements under this contract. The Contractor shall communicate with the CO on all matters pertaining to contract administration. Only the CO is authorized to make commitments or issue changes which will affect the scope, price, quantity, and/or quality of performance of this contract. In the event the Contractor effects any such change at the direction of any person other than the CO, the change shall be considered to have been made without authority and no adjustment will be made in the contract price to cover any increase in costs incurred as a result thereof.

(c) A certification that any of the items in paragraph (a) of this provision exists will not necessarily result in withholding of an award under this solicitation. However, the certification will be considered in connection with a determination of the Offeror's responsibility. (9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (c) Bidders/offerors and contracting officers are encouraged to use alternative dispute resolution (ADR) procedures to resolve protests at any stage in the protest process. If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.
