Philips Healthcare is the OEM and has proprietary ownership of all hardware and software to include PM services and parts. Philips Healthcare does not use other distributors.

Market research was conducted via VetBiz Registry and the SBA Dynamic Small Business Database.

These services have been provided for the GCVHCS, Biloxi MS since Oct. 2011 under a FSS NAC contract using limited source justification to Healthcare. Market research indicates Philips Healthcare has proprietary ownership.
