2. **Nature and/or Description of the Action Being Processed:** This request is for genomic-based laboratory services.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** Genomic Health, Inc. provides specialized Oncotype DX testing that is patented and can only be provided by this vendor. This assay provides Oncology providers with valuable information regarding optimal Chemotherapy treatments for colon and breast cancer patients.

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** An urgent and compelling need exists at this time. This medical center currently has a patient with known cancer awaiting treatment. The requested testing will direct the next step in the treatment program. Therefore, the outcome of the test will directly impact the treatment of this cancer patient and cannot be postponed.
6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** Not applicable; urgent and compelling need
7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** This test can only be completed by Genomic Health, as they hold the patent for Oncotype DX breast cancer assay testing.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** A brief internet search turned up the laboratory Genomic Health. Genomic

Health owns a patent on the Oncotype DX testing and is the only lab in the United States who can perform the test. Several websites were found attesting to the ownership of the patent.

9. **Any Other Facts Supporting the Use of Other than Full and Open Competition:** No other facts than what has already been stated, the results of this testing directly impact the treatment of this cancer patient and, therefore, necessitate an urgent and compelling situation.
10. **Listing of Sources that Expressed, in Writing, an Interest in the Acquisition:** Not applicable
11. **A Statement of the Actions, if any, the Agency May Take to Remove or Overcome any Barriers to Competition before Making subsequent acquisitions for the supplies or services required:** Until Genomic Health no longer solely holds the patent on this testing, then there will be no competition.
