2. Nature and/or Description of the Action Being Processed: This is a new action for provision and installation of a Siemens Energy Management Control System (EMCS).

3. Description of Supplies/Services Required to Meet the Agency's Needs: System cost estimate is approximately [REDACTED]. This EMCS system will provide control of the heating, ventilation, and air-conditioning systems, as well as monitor energy.

Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority): This system is a follow-on system, i.e. an add-on to an existing multi-state system with proprietary Siemens software. In particular, this system will be a Client of an already installed Host Parent system in Pensacola, Florida.

6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable: N/A. This is a proprietary follow-on system.

7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable: Price is fair and reasonable as compared to other similar systems. Siemens is a GSA contractor as well with reviewed competitive pricing.

Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted: No other known source due to proprietary vendor software and programming issues as a minimum. In the past, extensive market research has been conducted to identify any additional sources that could fulfill the governments requirement to interface with the Siemens proprietary system without a degradation of system functions.

9. Any Other Facts Supporting the Use of Other than Full and Open Competition: No other known compatible source.
