

SUMMARY OF RFP CHANGES

1. SF 33 Cover Page: Document headers changed to reflect Amendment 0013.
2. Block 9: The vendor shall submit a revised pricing proposal per Section L by 12:00 PM, Eastern Daylight Time, on 11 April 2019.
3. Section B: CLINs X001, X003, X004AA, X004AB, X005, and X008 the term “priced up to” is replaced with “priced at” to provided clarity.
4. Section B: CLIN/OPTION X002, CLIN description is updated for all performance periods.
