

**VISN 21 CCA Template for Limiting Competition**  
**DETERMINATION OF LIMITATION OF SOURCES**

1. **CONTRACTING ACTIVITY:** Department of Veterans Affairs Network Contracting Organization 21.

2. **DESCRIPTION OF ACTION:**

This action limits competition for the acquisition of Generator rental with installation.

3. **DESCRIPTION OF SUPPLIES/SERVICES:**

VAPAHCS requires a 500kw generator for 12 months. This includes a crane for installation and installation itself.

4. **AUTHORITY CITED:**

For open market \$150,000 or less, use: FAR 13.106-1(b), only one source is reasonably available because of sole source is authorized or required by statute (41 U.S.C. 253(c)(5)).

5. **REASON FOR AUTHORITY CITED:**

The authority cited in paragraph 4 must be used because is it allowed for in the Veterans Benefits Act of 2003 (15U.S.C. 657f). Per VAAR 819.7007, the Contracting officer may award contracts to SDVOSB concerns on a sole source basis provided:

- (1) The anticipated award price of the contract (including options) will not exceed \$5 million;
- (2) The requirement is synopsized in accordance with FAR part 5;
- (3) The SDVOSB concern has been determined to be a responsible contractor with respect to performance; and
- (4) Award can be made at a fair and reasonable price.

All of these conditions have been met, so the sole source is authorized.

6. **EFFORTS MADE FOR SOLICITING FROM OTHER VENDORS:**

This requirement will be synopsized in the GPE as required by FAR 5.201.

7. **FAIR AND REASONABLE COST DETERMINATION:**

The Contracting Officer has determined that the anticipated price will be determined to be fair and reasonable. A Price Negotiation Memorandum (PNM) will detail how the Government has determined that the anticipated costs will be fair and reasonable using those techniques at FAR13.106-3(a)(2).

As this service has been determined to be commercial, cost or pricing data will not be required. Pricing techniques such as are described in FAR 15.404-1(b)(2), will be used to establish price fairness and reasonableness.

8. MARKET RESEARCH:

Market research has been conducted IAW/FAR 10 for generator requirements.

9. SUPPORTING FACTS:

Any supporting data that is the responsibility of technical or requirements personnel (e.g., verifying the Government's minimum needs or requirements or other rationale for limited sources) and which form a basis for the justification have been certified as complete and accurate by the technical or requirements personnel.
