Interested firms must identify their company name and are asked to provide a capabilities statement (if available) and a letter on manufacturer's letterhead stating your company is an authorized dealer/distributor with all responses.

This notice is NOT a formal request for quote or proposals. No formal solicitation document exists at this time. The information in this notice is for information and planning purposes only and is not to be construed as a commitment by the government. No contract will be awarded from this notice.

Notice of Intent

If no responses are received, or a response from a firm that is considered not capable of fulfilling the requested supplies, the NCO-17 intends to award a sole source firm-fixed priced contract to Alliant Enterprises. The anticipated statutory authority permitting other than full and open competition is 41 U.S.C. 3304(a)(1), as implemented by FAR 6.302-1, Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements.
