8" Water Coupling Replacement

Expected Contract Duration: 15 days upon receipt of NTP

-- Services --

PROVIDE:

The contractor shall provide all necessary labor, services, and fittings (8" grooved couplings) to replace the existing 8" water fittings located in the basement of the Erie VAMC (BN055 Storage Area).

-- Project Scope --

GENERAL:

The existing 8" stainless steel water supply line servicing the hospital is currently leaking at two coupling locations. The repairs will require the removal of the existing 8" grooved couplings, replacement with new couplings, and re-insulation of the existing water line. The repair details are listed in the SPECIFICS section below.

SPECIFICS:

- Drain existing 8" pipe for fitting replacement
- Remove existing thermal insulation from the 8" water line fitting locations.
- Remove and replace leaking 8" Grooved Couplings
- Re-fill line and pressure test to operating pressure to test for leakage (90 psi)
- Re-insulate fittings

SECTION E - SOLICITATION PROVISIONS

The Government reserves the right to select a response that provides benefit to the government that exceeds the minimum requirement but is not required to do so. Responses may exceed the requirements stated in the SOW and this solicitation, but the Government is not requesting or accepting alternate quotes; each response must respond to the solicitation requirements.

(B) *The taxpayer is delinquent in making payment.* A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.

(ii) *Examples.*

(A) The taxpayer has received a statutory notice of deficiency, under I.R.C. Sec. 6212, which entitles the taxpayer to seek Tax Court review of a proposed tax deficiency.
