FAR part 10 assists requesting stations, program offices, and acquisition professionals in determining the most suitable approach for acquiring, distributing, and supporting supplies and services. A NAICS code search of Central Pharmacy Manager - Replacement Pill Packer was utilized and yielded a NAICS code of 339112, which includes corresponding index entries such as Surgical and Medical Instrument Manufacturing. The NAICS code size standard for 339112 is 1,000 employees to be considered a small business.
- (7) ANY OTHER FACTS SUPPORTING THE JUSTIFICATION: No other sources are available in the United States per contract V797D-30111 and VA Blanket Purchase Agreement No. VA245-BP-0145.
