3. Description of Supplies or Services:

This requirement is for the purchase of AcuStaf Labor Management software. The primary use of the software is scheduling staff, coordinate schedules, capture data, produce reports, and coordinate work assignments to meet patient care needs. This system will accommodate nurse staffing at all sites within Wilkes-Barre VAMC System to include all CBOCS. The staffing software is also capable of being implemented in other services/departments when the need arises.

This software is particular to one manufacturer, AcuStaf Development Corporation. This is a brand name only requirement due to the unique combination of AcuStaf software traits. This would include the ability to interface with VISTA and other VA software architecture.

This requirement includes a Base Year and four Option Years.

All CLINS are available on AcuStaf's GSA contract, which has been pre-determined to be fair and reasonable. To compete a new type of software inefficient and costly. At that there is no guarantee the new system would be less expensive than the existing system. Lastly, it is reasonable to assume that any new system being installed in the VA would also put us in a sole source situation in the future.

(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:

A search of VIP was conducted and returned no results. A search of the required items on GSA only returned AcuStaf's (Small Business) GSA contract. A search of SEWP showed two SDVOSB's resellers on SEWP with AcuStaf on their schedule, Four Points and Cynergy. All CLINs identified on SEWP show places of performance other than Pennsylvania. FPDS shows that AcuStaf has supplied the majority of VA contracts for this software, with an SDVOSB fulfilling a small number of contracts for this software.

(7) ANY OTHER FACTS SUPPORTING THE JUSTIFICATION:

While there are resellers, this requirement is predominantly for software licenses. The Non-Manufacturer Rule requires the VA to procure requirements such as this directly from the OEM when practical. Software and all required CLINS are on an FSS vehicle as well, which is a required source of supply.
