Gray Market Language (May 2016)

The Vendor shall be an Original Equipment Manufacturer (OEM) **authorized dealer, authorized distributor, or authorized reseller for the proposed equipment/system** such that the OEM warranty and service are provided and maintained by the OEM. All warranty and service associated with the equipment/system shall be in accordance with the OEM terms and conditions. The vendor shall provide new items ONLY; no remanufactured or "gray market" items. All items must be covered by the manufacturer's warranty.

Provision 52.212-2, Evaluation – Commercial Items (OCT 2014), applies to this acquisition.

The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price considered. The Government has determined in advance that the Best Value will be the offer with the lowest evaluated price among those offers rated "technically acceptable".

1. TECHNICAL

- a. Installation includes first removing the existing GH2 hoist - the contractor gaining access to the end of traverse rail (removing may be necessary) –remove end cap and end stop. Remove existing GH2 Lift and install GH3 Trolley for GH2 rail Provide and Install GH3+ 550lbs with integrated scale, clm software, and service modules and wi-fi ready with hanger bar.

- b. Provide and install GH3 conversion Trolley for GH2 rail connection.
- c. Provided and install GH3+ 550lbs with integrated scale, clm software, and service modules and wi-fi ready with hanger bar. Re-pin end stop and re-install end cap.
- d. Provide weight load testing in compliance with VHA Patient Safety Alert AL 14-07 and be installed to the moderate to high seismic area specification that the Charlie Norwood VA Medical center is in.
- e. Provide 3 years of warranty on motors, and other parts i.e. conversion trolley (GH3 Trolley to fit on GH2 rail), including the price of parts, labor and travel.

2. PAST PERFORMANCE:

Contractors will provide references indicating prior satisfactory services for installations of GH3+, including room-coverage systems mounted both by wall and by ceiling. Contractor will provide documentation of Guldmann Inc certified installers to perform the installation.
