This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written solicitation will not be issued.

Solicitation number is 36C24819Q1373 and is issued as a Request for Quote (RFQ). This solicitation documents and incorporates provisions and clauses in effect through Federal Acquisition Circular 2019-06, effective 10 September 2019. This solicitation starts 09/18/2019 and will end 10/09/2017 at 16:00 pm EST.

North Florida South Georgia Healthcare System, Network Contracting Office 8, Regional Procurement Office - East (RPO-E) intends to award a Firm Fixed Price service contract for Annual Maintenance and Inspection of Boilers located at the Malcom Randall VAMC in Gainesville, FL (3 boilers) and the Lake City VAMC in Lake City, FL (3 Boilers). This procurement is being conducted under FAR Subpart 13 and simplified acquisition procedures apply. Period of performance is 15 October 2019 – 14 October 2020. This is a base year with four (4) one year options requirement. The North American Industrial Classification System (NAICS) code for this procurement is 811310 with a small business size standard of \$8 million.

This procurement is set-aside 100% for Service Disabled Veteran Owned Small Business (SDVOSB). If award cannot be made, the solicitation will be cancelled; and the requirement resolicited.

This solicitation will use Comparative Analysis. Award will be made to the offeror determined to be technically acceptable; and price is determined to be reasonable; all eligible offerors may submit quotes. All offerors shall be registered in the System for Award Management (SAM) at <https://www.sam.gov> ; and [www.vip.vetbiz.va.gov](http://www.vip.vetbiz.va.gov) , if applicable, to be considered for an award

of a federal contract. The record shall be complete and not missing elements such as representations and certifications; and SDVOSB shall be certified.

The North Florida South Georgia Healthcare system requires Annual Maintenance and Inspection for Boilers located in Gainesville, FL and Lake City, FL. The contractor shall furnish all labor, materials, parts, supervisions, services and incidentals to Annual Maintenance and Inspection of Boilers located at the Malcom Randall VAMC in Gainesville, FL (3 boilers) and the Lake City VAMC in Lake City, FL (3 Boilers) as described in the attached Statement of Work (SOW). Contractors shall quote prices for each Contract Line Item Numbers (CLIN) for a Base year and 4 one year options. ***See Attached Price Schedule for quote submission***

- a) Provide methodology to be used to internally and externally inspect and test boiler safety devices on the six boilers that provide steam to the Malcom Randall VA Medical Center, Gainesville, FL and the Lake City VA Medical Center, Lake City, FL.
- b) Provide a list of personnel assigned to provide the titled service.
- c) Provide copies of Training Certification of personnel identified for boiler inspection and testing.

2) Past Performance

- a) Provide three (3) references of same scope and cost of work requested.
