**Section 3.02(1)** reads "Offers must be received at the location stated below, no later than 1:00PM Local Time on 09/27/2019"  
**Section 3.02(1)** is **AMENDED** and shall now read "Offers must be received at the location stated below, no later than 1:00 PM LOCAL TIME on October 11, 2019."

**Section 3.02(B) (1) (2)** reads "Date: September 27, 2019".

**Section 3.02(B) (1) (2)** is **AMENDED** and shall now read "Date: October 11, 2019".

**Section 1.05(B) (1) (2)** reads: "The primary functional entrance of the Building shall be within safely accessible, walkable ¼ of a mile distance of at least **five (5)** instances of amenities, two of which must be inexpensive or moderately priced fast-food or eat-in restaurants. The remaining **three (3)** instances must fall within at least 2 of the Diverse Use Categories shown below:"

**Section 1.05(B) (1) (2)** is **AMENDED** and shall now read: "The primary functional entrance of the Building shall be within 2-mile distance of at least **five (5)** instances of amenities, two of which must be inexpensive or moderately priced fast-food or eat-in restaurants. The remaining **three (3)** instances must fall within at least 2 of the Diverse Use Categories shown below:"

**Section 1.05 (C)** is **AMENDED** to add and shall read "or any state or locally available Dial a Ride transportation system."

All other terms and conditions of the RLP and Exhibits shall remain the same.
