1. **Contracting Activity:** Department of Veterans Affairs, Great Lakes Acquisition Center, 5000 West National Avenue, Bldg. 6, Milwaukee, WI 53295. (578-13-1-944-0006).
2. **Nature and/or Description of the Action Being Processed:** Justification and approval for other than full and open competition for the purchase of Thin Prep Pap Tests and associated processing supplies for the Edward Hines, Jr. VA Hospital, Hines, Illinois. Procurement will proceed on a sole source basis with Hologic Limited Partnership.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** The Medicine Service of Edward Hines, Jr. VA Hospital, in Hines, IL, has a requirement for Thin Prep Pat Tests and associated supplies. The following tests and supplies are required to sample and preserve for the testing of gynecologic and non-gynecologic specimens:



5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** The Medicine Service of Edward Hines, Jr. VA Hospital, in Hines, IL, has a requirement for Thin Prep Pat Tests and associated processing supplies to sample and preserve gynecologic and non-gynecologic specimens for cytopathological examination. These are the only tests and supplies that are compatible with the testing processor currently in place at the Edward Hines, Jr. VAH. These tests and supplies are only manufactured by Hologic Limited Partnership.
6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** As indicated by the end-user, these tests and supplies are only manufactured by Hologic Limited Partnership.
7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** Procurement for same and similar supplies have been ordered numerous times by the SPC for the Medicine Service of Edward Hines, Jr. VA Hospital in Hines, IL. Pricing is equal to or comparable to previous historical procurements.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** The Contracting Officer conducted no additional research. The end-users have researched the market and were unable to locate any additional competition for this requirement. Hologic Limited Partnership is the sole manufacturer of these supplies.


