3. Description of Supplies or Services:

The estimated value of the proposed action is [REDACTED].

This acquisition establishes a BPA purchase for Point of Care (POC) glucose testing materials for seven (7) participating VA Medical Centers within VISN 10 in response to a Veterans Health Administration (VHA) Directive outlining the policies and procedures for the proper management of patients receiving glycemia management. The total estimated value of the acquisition is \$683,100.00 at a payment rate of \$136,620.00 per year.

Roche Diagnostics is the best option currently for the VISN participants because the Roche model, Accu-Chek Inform II, is already in use and fulfills the government needs. Roche can additionally add in the interfacing component into the contractual agreement at an affordable cost to the government. All participating VISN sites currently have Roche meters and connectivity already pre-established. The Accu-Chek meter has been used in VISN 10 since 2000. Changing to another product requires VISN-wide rewriting of procedures, policies,

retraining, instrument validation processes, and connectivity re-establishment; all of which takes time and is inefficient causing a negative impact on patient care. This is the best use of government resources to continue with the FSS contract already in place. V797P-5279B was awarded to address the needs of VA medical centers that have a requirement for the reliable pathological testing outlined above. The contract was awarded after extensive market research, competition, legal review, and scrutiny by technical experts. Thus, the choice is technically sound, leverages the Governments buying power and is in the best interest of the Government to use.

6. DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:

A search of VetBiz using NAICS Code 334516, manufacturer keyword revealed zero SDVOSB/VOSB. A catalog review of GSA/NAC (V797P-5279B) listings resulted in a schedule contract for the requested items. Roche does not have any SDVOSB authorized distributors.
