Background Information:

Department of Veterans Affairs Structural Department at Loma Linda VA Medical Center requires preventive maintenance on (33) Hill-Rom Hospital Beds, to include (30) Hill-Rom Progressa Beds, and (3) Hill-Rom Compella beds.

Services to be provided:

The Contractor shall perform the following procedures for Preventive Maintenance:

3.1 Joint Commission Documentation to Certify electrical safety:

- a. Record leakage and resistance
- b. Inspect power cord and line filter for damage

3.2 Inspect operational functions:

- a. Siderail and patient controls and switches
- b. Bed movements: head articulation, foot retract/articulation, hi-low, chair, Auto Contour™ feature
- c. Siderail latching
- d. Siderail dampeners and cables
- e. Brake and steer
- f. CPR
- g. Emergency Trendelenburg and Reverse Trendelenburg
- h. Lockout controls
- i. Air surface zones are functional
- j. Bed exit/patient positioning monitor
- k. Scale (operates and settable to zero)
- l. Nurse call/communications functions
- m. TotalCare SpO2RT® percussion, vibration and rotation modules
- n. Indicators: LED and graphical interfaces
- o. TotalCare® Treatment surface control modules
- p. Air blowers

3.3 Visually inspect:

- a. Overall appearance (e.g., headboard, footboard, siderails)
- b. Leaks
- c. Labels are legible (control and warning labels)

- d. Casters
- e. Surface ticking and bladders for punctures and tears
- f. Internal mattress components (bladders, hoses) – TotalCare® Bed
- g. Inside of surfaces for fluids, moisture and stains – TotalCare® Bed

3.4 Calibrate and adjust:

- a. Scale
- b. Air surface pressures
- c. Angle/elevation limits: head articulation, foot retract/articulation, hi-low, chair, Auto Contour™ feature
- d. Hydraulic tank fluid level

3.5 Clean/degrease/lubricate:

- a. Drive screws, brakes, pivot points
- b. Air system filters
- c. Treatment surface control modules

3.6 Improve appearance:

- a. Paint touch ups
- b. Replace labels and plastic parts (i.e., roller bumpers)

4 Specific Requirements:

- a. The Contractor shall furnish all materials, equipment, tools, supervision, and personnel necessary to accomplish the remediation actions as indicated on the attached contractual documents.
- b. All employees of the Contractor shall comply with the VA security management program and obtain permission of the VA police, be identified by project and employer, and restricted from unauthorized access.
- c. Prior to the commencement of work, the Contractor shall conduct a site walk with the VA COR.
- d. The Contractor shall provide all documentation per Specifications and validated by the submittal registry to the COR prior to work.
- e. Any and all work performed will be subject to inspection and acceptance by both the safety supervisor and the structural supervisor or their designated representatives prior to payment of the invoice and or any progress payments.

The intended contract period will be for a base year and four (4) one-year option periods.
