The place of performance for this project is VAPHS, University Drive C, Pittsburgh, PA 15240. The existing ceiling fan in Room GM112 - Building 29, is to be replaced and relocated because the noise from the fan, when operating, is above acceptable levels for an occupied office space.

This project involves all labor, parts, equipment, materials, supervision, tools, and permits necessary to remove the existing ceiling fan and install a new fan to the exterior roof above GM112 in accordance with the Statement of Work included with this solicitation.
