Department of Veterans Affairs, VISN 23, VA Black Hills Health Care System- 568

*Provide Canon Copier Maintenance as per the quote and provide Cannon cartridges at no charge as needed for all Cannon copiers (listed) at Ft. Meade VA Hospital and VA Hot Springs South Dakota campuses.*

*Maintenance requires cannon parts for all cannon copiers to maintain the integrity of the cannon copiers.*

**2. Nature and/or Description of the Action Being Processed:**

Marco is the only authorized Canon dealer and servicing contractor for the Black Hills of South Dakota and is therefore considered a sole source vendor. VABHHCS is standardized with Canon copiers at both campuses. In order to maintain the integrity of the Canon copiers, Canon parts and repairs from an authorized Canon servicing representative is paramount to a successful maintenance program and reduces call backs and inconsistencies in inadequate parts or service.

**3. Description of Supplies/Services Required to Meet the Agency's Needs:**

This requirement is for October 1, 2012 through September 30, 2013. Servicing, maintenance, and parts for Canon copiers IR1023, IR3035, IR3025, IR330, IR3570, IR2200, IR2230, IR2270, IR2300, IR5055, IR2525, IR1530, IR5065, IR7130


