Kansas City Artificial Limb – Artificial Leg & Foot

1. **Contracting Activity:** This procurement is being made in support of (Department of Veterans Affairs, Network 15 Purchasing Agent, 4801 E. Linwood Blvd, Kansas City, Mo. 64128 by the Department of Veteran's Affairs, VISN-15 Contracting Office, 4101. 4th Street Trafficway, Leaveworth, KS 66048.
2. **Nature and/or Description of the Action Being Approved:** The purchase of a prosthetic limb component from a single source per medical determination of need. The request is for a firm fixed price contract of \$36,040.11 from Kansas City Artificial Limb; CAGE: 45E67, DUNS: 02-984-7670.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:**

New AK prosthesis with flexible inner liner, suction socket. Total contact acrylic socket with posterior thigh cut out: ischial containment socket alignable system. Test socket microprocessor knee-regular c leg. With compatible foot, Inner shaping cover and outer protective cover, slip whiz-pull sock #2.


4. **Statutory Authority Permitting Other than Full and Open Competition:**

- (1) Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements per FAR 6.302-1;

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** Prosthetic limb components are specified by the clinical team to meet the unique and comprehensive needs of each Veteran with amputation. The specific product described above has been determined by the clinical team to be the best device to treat the Veteran patient's medical condition and functional limitations. Substituting a prosthetic limb component with other than that specifically prescribed is beyond the role, competency and professional functions of the Contract Specialist and would be detrimental to the treatment of the Veteran patient. Full and open competition for the above described prosthetic limb component negates the clinician's subject matter expertise as related to the medical treatment for the individual Veteran. In this case the by-name device(s)

is/are the specific prescription and method of treatment for the Veteran-patient.


6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** Not applicable based on the medical determination described above.
7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** The price for the individual components are tied to the approved medicare geographic rates by the individual Healthcare Common Procedure Coding System numbers. These rates are based on the individual pieces of equipment, and the states wherein the equipment is being sold. As such, there is a commonly established price ceiling for each of these pieces of equipment based upon both type and location. Based upon the preceding information; the proposed price for this contract of \$36,040.11 with Kansas City Artificial Limb will be fair and reasonable.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** Market research was not conducted based on the medical determination described above.
9. **Any Other Facts Supporting the Use of Other than Full and Open Competition:** VAAR 806.302-5(b)(1) allows an exception to full and open competition for prosthetic appliances in accordance with 38 U.S.C. 5 8123. *and 41 USC 253(c)(5)*
