File Storage for Albuquerque VA Regional Office

1. Contractor will transport files from Albuquerque VA Regional Office, (second floor of the Dennis Chavez Federal Building, 500 Gold Ave. SW, Albuquerque, NM) to the storage facility at commencement of the contract, and return the file cabinets to the same location at termination of the contract.
2. File cabinets will be secured in a manner that will prevent unauthorized access to the contents of the file cabinets during transportation.
3. Approximately 37,200 files are housed in 567 VA-owned five-drawer vertical file cabinets requiring transportation and storage.
4. Sufficient space must be allocated to allow access to all the file cabinet drawers, with a minimum aisle width of 36".
5. Storage facility must restrict access to the file cabinets by unauthorized personnel.
6. Storage facility must be within an eight mile radius of 500 Gold Ave. SW, Albuquerque, NM.
7. Storage facility will permit access to VA personnel up to three times per day, Monday through Friday, between the hours of 0700 and 1700. VA personnel may be working in the file bank at any time during those hours.
8. Storage facility will be sufficient climate controlled to prevent damage to paper files and allow personnel to work in comfort.
9. Storage facility will provide sufficient lighting to allow personnel to view files.
10. Storage facility will provide power outlets within the storage area.
11. Storage facility will have fire suppression capability sufficient to minimize damage to the files in the event of a fire.
12. Storage facility will have flood prevention measures in place.
13. Term of occupancy will commence around the first business day of May 2013 at the earliest. Expected duration is a base period of six months with a month to month option. The VA shall provide a 15 day notice of termination while under the month to month.
14. Term shall not exceed 12 months.
