1. General New Work Note D: REVISE note to read: "PROVIDE CEMENTITIOUS CONCRETE FLOOR UNDERLAYMENT OVER ENTIRE EXISTING SLAB SURFACE, TYP. SEE 2/AS4-1 & 1/AS4-2." TOP OF UNDERLAYMENT SHALL MATCH TOP OF EXISTING TERRAZZO ELEVATION. FEATHER TOP OF UNDERLAYMENT AS REQUIRED FOR TOP OF NEW FLOOR FINISH TO MEET FLUSH WITH TOP OF EXISTING ELEVATOR THRESHOLD AND STAIR FLOOR FINISHES.

**SHEET 110-AS4-1**

1. Wall Section #1: CHANGE the note: "REMOVE FLOOR FINISH AND SETTING BED, TYP." to read "REMOVE FLOOR FINISH AND SETTING BED, TYP. ACTUAL THICKNESS MAY VARY SIGNIFICANTLY".
2. Wall Section #1: CHANGE SUBSLAB ELEVATION "-0'-1" to read: "+/- -0'-1" F.V."
3. Wall Section #2: CHANGE the note: "PATCH FLOOR WITH CEMENTITIOUS CONCRETE FLOOR UNDERLAYMENT FOR NEW FINISH" to read "FLOOR WITH CEMENTITIOUS CONCRETE FLOOR UNDERLAYMENT FOR NEW FINISH".

4. Wall Section #3: CHANGE the note: "PATCH FLOOR WITH CEMENTITIOUS CONCRETE FLOOR UNDERLAYMENT FOR NEW FINISH" to read "FLOOR WITH CEMENTITIOUS CONCRETE FLOOR UNDERLAYMENT FOR NEW FINISH".
