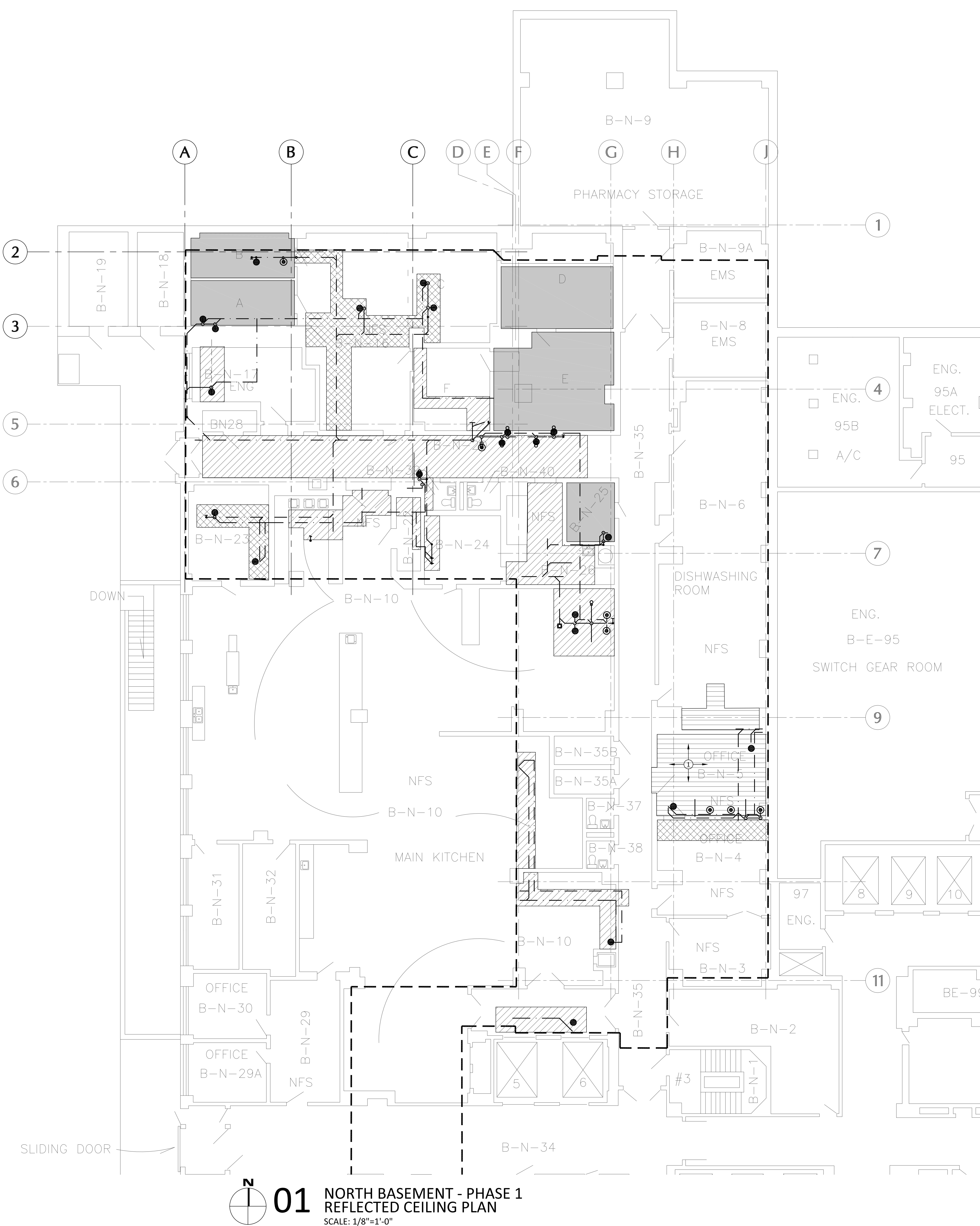

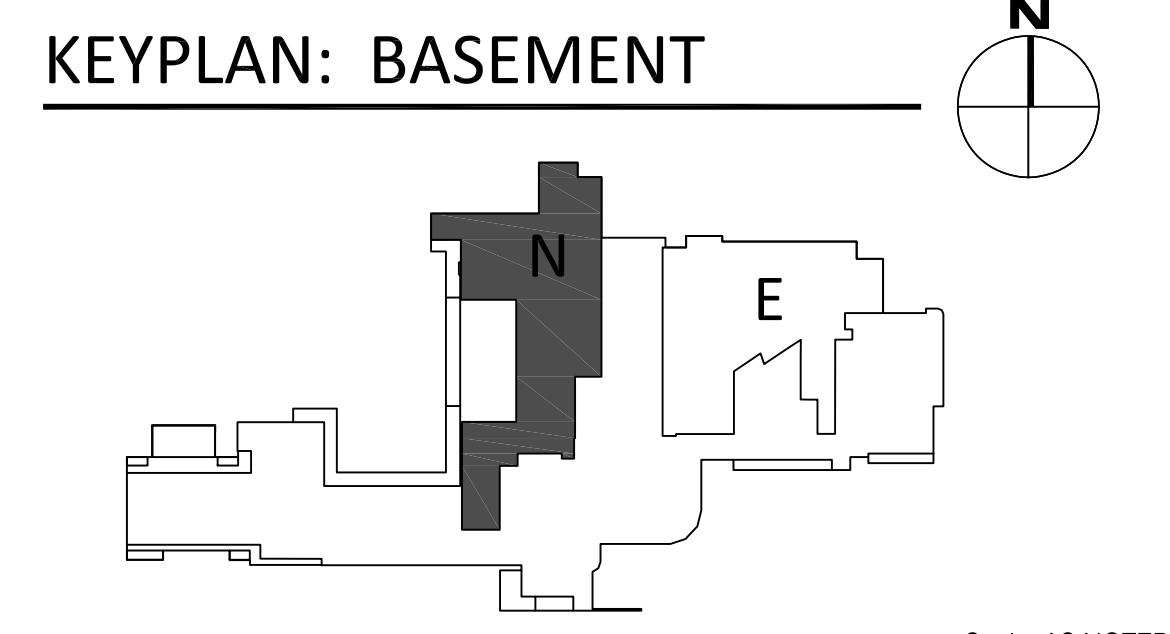

 - WHERE WALLS, CEILING OR CHASES ARE REQUIRED TO BE REMOVED FOR UTILITY ACCESS, CONTRACTOR IS RESPONSIBLE TO PATCH IN/ILL TO RECEIVE NEW FINISHES TO MATCH EXISTING ADJACENT. REFER TO MEP DRAWING FOR ADDITIONAL DEMOLITION OR RELOCATION WORK.
