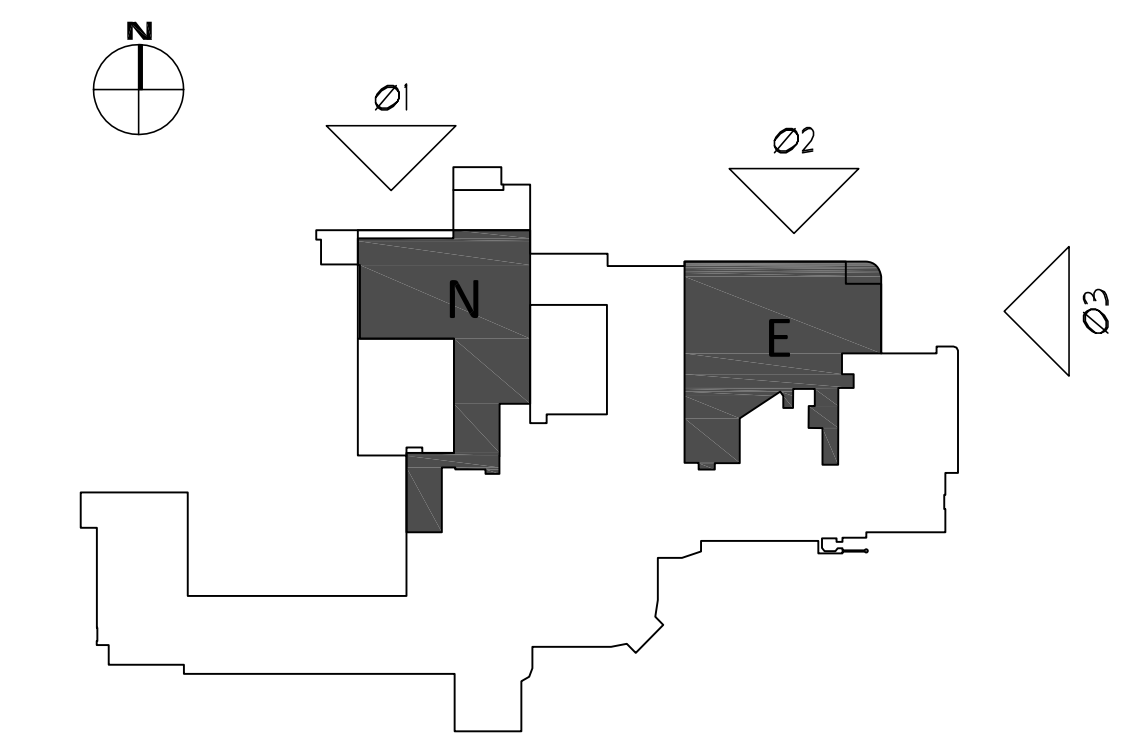


1. EXISTING BRICK WALL TO REMAIN
2. NEW ADDITION WITH BRICK EXTERIOR WALL TO MATCH EXISTING ADJACENT BRICK IN COLOR, SIZE AND PATTERN.
3. LINE OF EXISTING BRICK COLUMN TO REMAIN
4. NEW ALUMINUM STOREFRONT
5. DECONTAMINATION DOOR
6. CONTROL JOINT
7. CAST STONE COPING
8. NEW LIGHTED EMERGENCY SIGNAGE, CONTRACTOR TO PROVIDE MOUNTS AND POWER
9. REMOVE AND REUSE EXISTING AIR CURTAIN UNIT, REFER TO MEP.
10. EXISTING STOREFRONT SYSTEM TO REMAIN.
11. GENERAL CONTRACTOR IS TO RE-LABEL EXISTING EMERGENCY SIGNAGE TO READ "CLING ENTRANCE"
12. JOINT SEALANT
13. GENERAL CONTRACTOR IS TO PROVIDE NEW EXTERIOR SIGNAGE (CEILING MOUNTED) ABOVE AUTOMATIC DOOR. COORDINATE SIGNAGE MOUNTING DETAILS WITH VENDOR. SIGNAGE SHALL READ "EMERGENCY" IN RED LETTERING, 12" HIGH (CONFORM WITH ARCHITECT) AND LIGHTED. PROVIDE POWER, REFER TO ELECTRICAL DRAWINGS.
14. GENERAL CONTRACTOR IS TO PROVIDE NEW EXTERIOR SIGNAGE (CEILING MOUNTED) ABOVE AUTOMATIC DOOR. COORDINATE SIGNAGE MOUNTING DETAILS WITH VENDOR. SIGNAGE SHALL READ "AMBULANCE" IN RED LETTERING, 12" HIGH (CONFORM WITH ARCHITECT) AND LIGHTED. PROVIDE POWER, REFER TO ELECTRICAL DRAWINGS.
15. ACCESS BUTTON (IN USE AFTER HOUR) TO BE CONNECTED TO ED NURSE STATION.
16. ACCESS BUTTON TO BE CONNECTED TO ED NURSE STATION.
17. EXISTING METAL CANOPY TO BE MODIFIED TO ACCOMMODATE NEW BUILDING ADDITION.
