1. **Contracting Activity:**

Department of Veterans Affairs, VISN 10, Dayton VA Medical Center Engineering Service (138)

2. **Nature and/or Description of the Action Being Processed:**

The requirement for the contractor to use a Guldmann patient lift for the Site Prep for CT Scanner project no. 552-CSI-333 with an estimated construction cost of \$4,570.00. The cost of the Guldmann patient lift components is estimated at \$4,570.00.

3. **Description of Supplies/Services Required to Meet the Agency's Needs:**

As part of a project to build an addition to and renovate B-335 at the Dayton VAMC, a patient lift must be installed in the CT scan room; patient lifts are necessary to assist in safe patient handling throughout the medical center.

All patient lifts that are used at the Dayton VAMC are by Guldmann. Guldmann must continue to be used to ensure that all of the specifications for lifting speed and maximum weight capacity are met.

7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:**

The best interests of the government are served through the use of this product. The pricing will be provided as part of equipment available in the commercial marketplace. The price will be determined to be fair and reasonable to the government based on competition. The cost associated with this initiative is estimated at \$4570.00.

8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:**

No other brands of ceiling lifts offer the specifications for lifting speed and maximum weight capacity in a single product. Other brands do not have integrated scales or statistical function for management use as the Guldmann.
